Council called to order at 8:30 P.M.
Mayor DeGross in the Chair.

Roll called and the following Members answered
Alderman Brown Crocker, Miller, Millett, Hartley, Halle
Platt and Strong

Absent Aldermen Metz and Sheehan
Quorum present

His Hon. the Mayor stated that he had called them
together for the purpose of receiving the report of the Committee,
to whom was referred the Ordinance Regulating Mortals and
to transact such other business as might properly be brought
before them

An Ordinance appropriating the sum of Two hun-
dred and fifty dollars for the repairing of the streets
near the White place which passed its first reading Feb'y
9th 1878 was taken up and read the second time

Alderman Hartley moved to suspend the rules
and put the Ordinance on its ^{third} ~~second~~ reading

to whom was referred the Ordinance regulating Markets
have the honor to report as follows

We recommend that the market limits be
established as heretofore and offer the accompanying
amendment to fill blank in Article No 30

We also recommend that the penalties for
violations of this ordinance be incorporated in a
single section or article with proper reference to
all the sections or articles contained. This will save
expense in printing. There are some unimportant
amendments which we will offer as to form, on
second reading, not necessary to be enumerated here
with these amendments we respectfully recommend
the passage of the Ordinance

The following is a Memorial Report presented
by Committee to whom was referred the Ordinance
Regulating Markets

To His Hon the Mayor and Board of Aldermen
of the City of Austin

Your committee to whom was referred
Ordinance on Markets, have carefully considered the
same, and report it back and recommend that
in Article 30 after the word follows the words
Lots Nos nine, Ten, Eleven, and Twelve in Block
No Ninety Eight of said City be inserted, and as
a substitute for Article 32 Recommend the adoption
of the following,

Any person after having paid his or
her license or occupational Tax to the City Assessor and
collector, and received a Certificate to that effect

from said Officer and Collector, may open, erect, establish or carry on any where in the City of Austin outside of the Market limits as named in Article 30. Market or Markets for the sale of Meats, Vegetables, and other produce, provided such person or persons shall at all times comply with the Sanitary and other regulations enacted by the City Council. - And further recommend that Articles 33 and 34 be stricken out and that Article 35 be changed to read as follows to wit

The City Council reserves the right and privilege as conferred upon it in the Charter of the City of Austin Article - Sec. - to establish and regulate Markets within said City

The minimum price for the rent of stalls in the City Market for the Year commencing March 1st 1898 and for each and every year thereafter until the same is altered or amended shall be Twenty five dollars.
