

ORDINANCE NO. 840726-Z

AN ORDINANCE AMENDING CHAPTER 13-2 (ZONING) OF THE CODE OF THE CITY OF AUSTIN, 1981; AMENDING THE USE AND HEIGHT AND AREA MAPS THEREOF; CHANGING THE ZONING ON THE PROPERTY IN THE "LAKE AUSTIN ZONING STUDY FROM INTERIM "A", RESIDENCE, INTERIM "LA" LAKE AUSTIN RESIDENCE, AND "A" RESIDENCE, FIRST HEIGHT AND AREA DISTRICT TO "AA" RESIDENCE, FIRST HEIGHT AND AREA DISTRICT; SUSPENDING THE RULE REQUIRING THE READING OF ORDINANCES ON THREE SEPARATE DAYS; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. That Chapter 13-2 of the Austin City Code of 1981 is hereby amended to change the USE and HEIGHT and AREA designations from Interim "A" Residence, Interim "LA" Lake Austin Residence and "A" Residence, First Height and Area District to "AA" Residence, First Height and Area District, on that property which is within the incorporated city limits of the City of Austin, Travis County, Texas, and identified by the zoning maps which are attached hereto and made a part hereof, as Exhibit Numbers 1 - 101.


PART 2. It is hereby ordered that the USE and HEIGHT and AREA maps accompanying Chapter 13-2 of the Austin City Code of 1981 and made a part thereof shall be changed so as to record the change ordered in this ordinance.

PART 3. The rule requiring that ordinances shall be read on three separate days is hereby suspended, and this ordinance shall become effective ten (10) days following the date of its passage.
