## 5. Staff Briefings

- a. Legislative, Regulatory and Policy update. (Rondella Hawkins) (wp5)

Rondella Hawkins, Manager, City of Austin Telecommunications and Regulatory Affairs (TARA) reported that the FCC is scheduled to release its National Broadband Plan report on March 17<sup>th</sup>. Municipalities across the country are engaged with Congressional Reps and with the Administration that there is a concern there will be a recommendation by the FCC that the right of way compensation that is paid by the telecomm providers to use the rights of way to deploy their infrastructure will be limited to a cost base rather than what is traditionally compensated for rental of the right of way. This could be revenue loss to municipalities.

- a. Discussion and possible action on 2010 GTOPs grant recommendations. (Sheena Harden) (wp2)

**Motion to accept the Grant for Technology Opportunities Program (GTOPs) Review Committee's 2010 GTOPs recommendations were as follows:**  
**American YouthWorks awarded \$24,700.; Austin Academy awarded \$7,000.; Austin Children's Museum awarded \$13,200.; Austin Group for the elderly awarded \$15,000.; El Buen Samaritano awarded \$16,000.; Girlstart awarded \$20,000.; Goodwill awarded \$15,700.; Latinitas awarded \$15,400.; and Multicultural Refugee Coalition awarded \$23,000**  
**was approved on Commissioner Touvell's motion; Commissioner Williams' second on a 7-0-0 vote.**

- b. Update reports on networking relationships with other boards/commissions and groups, citywide and Austin Community Technology and Telecommunications Commission (ACT&TC) information items.

Commissioner Rosenthal stated that City of Austin has partnered with a community group called Open Austin. OpenAustin was formed by citizens interested in City of Austin web strategy and approach. Through a series of conversations, common ground was developed between the City and OpenAustin to work together in a formal and recurring way. The goal is to develop new capacities for the City of Austin website while reducing or eliminating costs.

Commissioner Rosenthal stated two months ago this Commission passed a resolution with respect to the City's comprehensive plan asking for consideration for broadband and technology. This was presented to Neighborhood Planning and Zoning for consideration to be included in the comprehensive plan.

**8. City of Austin response to Google's "Fiber for Communities" Request for Information to build an ultra high speed broadband network in Austin. (wp4)**

**The Commission will suspend its normal order of business to take up this item at approximately 7:00 PM.**

**Members of the public are invited to appear before the Commission and speak up to 3 minutes on the City of Austin response to the Google RFI. The Commission especially invites presentations from residents on: how they would use a high-bandwidth Internet connection, creative uses for such a facility, and points to present to Google that recommend Austin as a location for their fiber network trials.**
