Carbon Footprint Calculator – Progress on Goals

Users Goals

- 500 unique users per month for the first 3 months
- 250 unique users for the subsequent
 9 months
- 10% return rate of repeat log-ins

Current Users

- January/February 593 new registrants
- March 81 new registrants
- April (to 4/5) 5 new registrants
- 12.8% return users


Ozone Attainment

Ground-Level Ozone is a federally regulated air pollutant formed from NOx + VOC + Sunlight

EPA revised the standard to 75 ppb in 2008 and now is proposing a value between 60 to 70 ppb

Design Value is 3-Year average of the annual 4th highest 8-hour ozone maximum at regulatory monitor

EPA designation based on design value from 2008 – 2010 monitoring data
