Solid Waste Advisory Commission 2008-2009 Work Plan Accomplishments

Construction & Demolition Debris Recycling (September 2008)

SWAC formed a subcommittee in the spring of 2008 to discuss and evaluate the feasibility of expanding green building and C& D Recycling in the Austin community. The Subcommittee determined that it would be best to partner with other entities around the City and re-visit the community's infrastructure to recycle C&D Debris at a later date. As a result of the subcommittee meetings, SWS Staff partnered with CAPCOG, Austin Energy, the Convention Center, and TXDOT to hold a C&D Recycling Regional Summit in May 2009.

Single Stream Recycling (October 2008)

SWS fully implemented Single Stream Recycling Curbside Collection Program in October 2008. Recyclables collected increased by approximately 46%. Education continues regarding the program. The program continues to be very successful in terms of improving operational efficiencies, increasing the diversion of materials from the landfill, increasing customer participation, and generating/sustaining community support.

Alternative Energy Conversion Technologies (October 2008)

Austin Energy provided a presentation to discuss alternative energy technologies. Staff discussed the differences in incineration, plasma arc technology, etc.

Zero Waste Strategic Plan (January 2009)

SWAC Reviewed and recommended that Council approve adoption of the Zero Waste Strategic Plan. Implementation is on-going with numerous outreach and education initiatives planned throughout the community.

Solid Waste Services Management Audit/Review (Summer 2009)

Completed. A new SWS Director was recruited and hired. Bob Gedert is scheduled to begin on February 1, 2010.

Pay-As-You-Throw Rate Structure Subcommittee (Summer 2009)

SWAC formed a subcommittee in the fall of 2008 to discuss the rate structure. The Subcommittee provided staff with valuable input. Staff presented the FY10 SWS budget to SWAC with a recommended increase that was fairly consistent to the Subcommittee's recommendations. SWAC recommended a budget with a higher increase than staff projected. Council passed the FY10 budget that included a rate increase for the 90 gallon containers.

Integrated Solid Waste Management Master Plan (June 2009)

On June 18, 2009, Council authorized staff to negotiate with negotiate HDR Engineering, Inc for development of the ISWMMP and return to execute the contract. Staff solicited and received significant community input regarding the scope of services and initiated

negotiations with HDR. The item is tentatively scheduled for consideration by SWAC on February 10, 2010, and then to Council by February 25, 2010.

Composting Program (October 2009)

A composting rebate/incentive program was approved in the FY10 budget. Staff is developing the administrative process to implement the incentive program and partner with local organizations to provide compost training programs for the community.

Single Stream Recycling Facility Request for Proposals (December 2009) RFP advertised on November 16, 2009. The proposals are scheduled to go back to Council between June – August of 2010.

Commercial/Multi Family Recycling Ordinance

SWAC formed a Subcommittee to discuss and develop amendments to the ordinance. Meetings began on September 9, 2010. The Subcommittee expects to forward its initial recommendations on February 10, 2010. Stakeholder meetings continue.

Revised Hauler License Fee (On-going)

Subcommittee was created to review and recommend possible changes to the current ordinance. This issue is ongoing.

PURCHASING: Cooperative Purchase

MBE/WBE: This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). This contract is a Cooperative Purchase; therefore, it is exempted under Chapter 791 of the Texas Government Code and no goals were established for this solicitation.

This contract is for the purchase of 16,704 residential garbage carts and 4,704 single-stream recycling carts, including lid graphics, for the Solid Waste Services Department (SWS).

The garbage carts are to be issued for the SWS Pay-As-You-Throw Program, which requires SWS customers to use a City-issued cart for the removal of residential garbage. The purchase of garbage carts is necessary to provide SWS with a sufficient supply of 30, 60, and 90-gallon garbage carts readily available to replace existing customers' broken carts and to issue new carts to new customers on an asneeded basis.

The recycling carts are to be issued for the SWS Single-Stream Recycling Program, which was initiated in October 2008. The purchase of recycling carts is necessary to provide SWS with a sufficient supply of 90-gallon recycling carts readily available to replace existing customers' broken carts and to issue new recycling carts to new customers on an as-needed basis.

Toter Incorporated is under contract with CPA to supply various types of refuse containers (two-wheel carts) and services statewide as a result of a competitive bidding process. Utilizing CPA contracts provides for volume discount pricing as well as the earliest opportunity to get the City's equipment on order.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$70,000 is available in the Fiscal Year 2009-2010 CIP Budget of the Solid Waste Services Department. Funding for the remaining 28 months of the original contract period and extension options is contingent upon available funding in future budgets.

FISCAL NOTE: A fiscal note is required.

PURCHASING: Sole bid received.

MBE/WBE: This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

This contract will provide for leachate and methane gas collection and control system operation maintenance and repair services for 67 landfill extraction wells, multiple condensate collection locations, below-grade high-density polyethylene header piping, one blower, one enclosed candlestick-type flare, and associated appurtenances and controls at the Solid Waste Services Landfill located at 10108 FM 812. This agreement will also provide for non-routine and emergency services for all associated components, as well as greenhouse gas monitoring and reporting.

The contractor will conduct monthly monitoring and adjustments of the well field to ensure proper balancing of the landfill gas extraction wells. Routine operations and maintenance will be performed at each of the 67 landfill gas extraction wells. Monitoring of the landfill gas quality and flow at the blower/flare station will be performed on a monthly basis and the contractor will document the following operational data for each well: 1) wellhead vacuum; 2) differential pressure; 3) landfill gas flow; 4) landfill gas composition (i.e., methane (CH4), carbon dioxide (C02), oxygen (O2), balance gases; 5) landfill temperature; 6) wellhead condition; and 7) measurement of liquid levels in wells.

In accordance with the Mandatory Greenhouse Gas (GHG) Reporting Rule recently promulgated by the U.S. Environmental Protection Agency (EPA), all landfills that accepted waste after January 1, 1980 must report methane emissions annually if the landfill emissions exceed 25,000 metric tons of carbon dioxide equivalents (CO2e). This contract will provide for the installation of a flow meter and electronic chart recorder to monitor landfill gas flows, and the contractor will monitor the methane content of the gas each

The annual estimated amount of the contract is \$105,000. A complete bid tabulation is on file in the Purchasing Office and is on the City of Austin, FASD Purchasing Office website.

PRICE ANALYSIS

- a. Sole bid. Other potential bidders were notified of the solicitation, but none were received.
- b. Fifty-six notices were sent, including six MBEs and four WBEs. One bid received, with no response from the MBE/WBEs.
- c. The pricing offered reflects a 22% increase to the previous contract award in November 2006. The increase is due to the additional cost of weekly monitoring of methane gas and installation of a flow meter and electronic chart recorder required by the EPA Mandatory Green House Reporting Rule.

APPROVAL JUSTIFICATION

- a. Sole bid received. SCS Field Services is the current provider of these services.
- b. The Purchasing Office concurs with the Solid Waste Services recommended award.
- c. Advertised in the Austin American-Statesman and on the Internet.

History of SWS E-Waste Collections

- Bulk Collection Program
 - Since 1990s City's bulk program collects obsolete computer and electronic equipment, including TVs.
 - Currently monitoring the amount of e-waste collected during bulk collection cycles.
 - Next step: evaluate the logistical challenges and potential costs of removing e-waste from the bulk collection routes.



History of SWS E-Waste Collections

- SWS Collection Events
 - 2000 & 2001 Annual collection events held at the Household Hazardous Waste facility.
 - During the two collection events, more than 20,000 pounds of computer equipment was collected from nearly 400 households.



History of SWS E-Waste Collections

- E-Waste Recycling Partnerships
 - 2005-2006-The Austin Computer Recycling Pilot Project. Partners included: DELL and Goodwill Industries.
 - 2008-TV and electronic item collection event.
 Partners included: Goodwill Industries, Walmart,
 Round2 Technologies.

Computer Equipment Recycling Program (HB2714)

Effective September 1, 2008

- Computer producers are required to provide free and convenient recycling for computers owned by consumers and home-based businesses.
 - Consumers are not required to recycle e-waste
- HB2714 covers desktop and laptop computers and monitors. Keyboards and mice of same brand as computers are also covered.
 - TVs not included
- Companies are allowed to tailor their recovery and recycling plans to their own business model.






