I. Call meeting to order.

b. Report of the Review and Evaluation Subcommittee. Bill Kelly passed out a draft resolution for consideration of the Advisory Committee concerning the FY 2011 budget recommendation. Bill went over the resolution and recommended that the Advisory Committee submit a document separate from the budget being submitted by DACC staff. Charles Locklin passed at a document labeled "Some Guiding Principles for the Court Advisory Committee to consider in developing a resolution to the City Council and City Management concerning budgetary increases in the Community Court's operating funds."

After discussion, Bill Kelly made a motion to approve a version of the resolution from the subcommittee, with consideration of input from Committee members. All in favor. Marshall Jones was to finalize the resolution.

c. Review and discussion of the DACC staff budget recommendation for FY2011. Pete Valdez went over his budget request with the Committee, including his request for funds for case management, substance abuse treatment, Project Recovery, and transitional housing.
