A motion to approve the May 18, 2010 minutes as amended was approved on a 4-0-1 vote (Kirk abstaining).

#### D. Regular Agenda

1. Update on options related to the enforcement and Mitigation for Heritage Trees.

A motion that - Commissioner Chimenti and Commissioner Small, along with City staff, including Michael Embesi and Robert Heil, and two representatives of the Urban Forestry Board and two representatives of the Environmental Board, would meet and before the next committee meeting and assemble a range of additional mitigation and enforcement options for tree preservation, and that these results will be reported back to the committee was approved on Commissioner Chimenti's motion, Commissioner Small's second, on a 5-0 vote.

4. Discussion and action on an amendment to create a zoning overlay district in which Group Residential would be a conditional use in (MF-4) multi-family zoning.

A motion to amend the land development code to create a zoning overlay district encompassing CANPAC area, with the exception of the UNO and NUNA areas, in which the group residential use would be a conditional use in MF-4 base zoning, was forwarded to the Planning Commission with a recommendation for approval on Commissioner Chimenti's motion, Commissioner Kirks second, on a 5-0 vote.
