

Building and Fire Code Board of Appeals MINUTES **REGULAR MEETING** September 17, 2009

The Building and Fire Code Board of Appeals convened in a regular meeting on September 17, 2009 at One Texas Center located 505 Barton Springs Road, Suite 500

Alan Schumann called the meeting to order at 1:45 PM.

1. APPROVAL OF MINUTES – Approval of minutes postponed until everyone agrees with amendments.

2. CITIZEN COMMUNICATIONS – None

- 3. **DISCUSSION** Retroactive Alarm System requirements for multi-family dwellings
 - **4603.6.6** noted as being the same as **907.3.1.7** in 2003 code regarding alarm systems per Carl Wren. There is no change to this code. Adopted January 1, 2006 when 2003 code was adopted. This code has not been actively enforced until January 2008. In regards to independent exits, would have to determine what would be considered an independent exit and which would comply and not comply in regards to the retroactive alarm systems required for multi-family dwellings. Currently fifteen apartment complexes have been identified as having this retroactive alarm system.
 - Apartment Association does not require retro-active alarm system. Chief Smith would like to get addresses of all apartments built in the 80's to find out which complexes would need this system.
 - Kristen Gast (AAA President) requested a table decision to put a committee together and come back with more information prior to implementation of the retroactive alarm system requirements. She's concerned about the dollar amount involved with the noted retrofits.
 - Discussion regarding 2009 International Fire Code:
 - **105.6.48** Fire protection system permits: Board Member Frank Haught questioned inspections that are not allowed to access condos to inspect for fire so they are now yellow tagging buildings.
 - **105.7.14** Temporary membrane structures and tents
 - **Independent Exits:** Leave language as is and have interpretation from Board in regards to how it will be enforced. Goal: September 30th to craft language for presentation to Board.
