Approve the award, negotiation, and execution of a 60-month revenue concession agreement with IN-TER-SPACE SERVICES, INC. dba CLEAR AIRPORTS CHANNEL, Allentown, PA, for advertising services at Austin-Bergstrom International Airport. This contract is projected to generate \$550,000 in revenue to the City in Fiscal Year 2011. Revenue over the life of the initial 60-month term of the contract is estimated at \$2,750,000. Authorize award, negotiation, and execution of a 60-month requirements service contract through the State of Texas Department of Information Resources with **SUMMUS INDUSTRIES, INC**, (**MB**) Sugarland, TX, for a Microsoft Enterprise License Agreement (EA) and Software Assurance in an estimated amount not to exceed \$14,061,297. *[Item postponed until further notice]*

Authorize award and execution of a 36-month requirements supply contract with GEXPRO, Austin, TX for programmable logic controllers the Aviation Department in an estimated amount not to exceed \$162,000, with two 12-month extension options in an estimated amount not to exceed \$54,000 per extension option, for a total estimated contract.
