

EARLY CHILDHOOD COUNCIL MINUTES

REGULAR MEETING Tuesday, December 8, 2009

The Early Childhood Council (ECC) convened for a regularly scheduled meeting on Tuesday, December 8, 2009, at Austin City Hall, Room #1101, 301 West Second Street, in Austin, Texas.

CALL TO ORDER: Chair Aletha Huston called the meeting to order at 9:03 a.m.
