

## EARLY CHILDHOOD COUNCIL MINUTES

## REGULAR MEETING Tuesday, April 13, 2010

The Early Childhood Council (ECC) convened for a regularly scheduled meeting on Tuesday, April 13, 2010, at Austin City Hall, Room #1101, 301 West Second Street, in Austin, Texas.

Board Members in attendance are listed on the attached attendance roll sheet. Health and Human Services Department (HHSD) staff in attendance was Ron Hubbard. Cindy Gamez, Jacquie Porter, Nicole Robinson, Cris Perez, Ellen Balthzar, Lanie Boose, and Lisa Martin attended as guests.

CALL TO ORDER: Chair Aletha Huston called the meeting to order at 9:03 a.m.

- 1. INTRODUCTIONS: The Chair asked the guests to introduce themselves.
- 2. CITIZEN COMMUNICATION: None.
- 3. PRESENTATION: Cris Perez, Nicole Robinson and Cindy Gamez presented about Workforce Solutions Child Care Services eligibility processes and new attendance recording process.
- 4. APPROVAL OF MINUTES: The minutes from the regular meeting on March 9, 2010 were approved on Council Member Keith-Thompson's motion with Council Member Wallace's second on a 11 0 vote with Council Member Paver arriving after the vote.

## 5. COMMITTEE REPORTS:

- a. EXECUTIVE The FamilyConnections situation was discussed including how the ECC should respond. Holding a special called meeting regarding the future uses of FamilyConnections' funding was approved on Council Member Rodriguez's motion with Council Member Carpenter's second on a 12-0 vote.
- b. POLICY DEVELOPMENT AND RESEARCH Council Member Rodriguez discussed the progress on the downtown child care survey.
- c. PROVIDERS Council Member Sanford said reported on an upcoming Child Care Liscensing hearing. She reviewed the proposed agenda for the June 3<sup>rd</sup> evening ECC meeting.
- d. FINANCE Council Member Carpenter discussed the ECC's funding recommendations and plans for meeting with Council Members and Commissioners.

- 6. SUCCESS BY 6: Council Member Carpenter updated the ECC on SB6 activities. SB6 conducted a survey of child care center directors.
- 7. STAFF BRIEFING: Ron Hubbard, Early Childhood Coordinator, reported that CDBG funds are level for next year, and on his work around the FamilyConnections issues.
