Recommendation

The Environmental Board supports the Bulkheads and Trams shoreline protection requirements for development along Lake Austin, Lady Bird Lake and Lake Walter E. Long presented to the Board on July 21, 2010. The Environmental Board requests that staff present the final Bulkheads and Trams Ordinance, and the proposals for the Environmental Criteria Manual at a future Board meeting

This is to include the prevention of vertical bulkheads and promotion of stable shorelines with materials and designs that will provide the environmental function of native riparian vegetation and shoreline geomorphology while providing the necessary erosion control desired by property owners.

The Environmental Board further recommends that the code and criteria changes regarding lake shoreline protection be processed in conjunction with the proposed code amendments relating to trams and boat docks access that are already under consideration.
