## City of Austin Tree Arborist conditions:

1. 150% mitigation for both trees given their respective conditions.

#### Rationale

Both trees have severe structural and physiological defects. (27 inch Cedar Elm, 24 inch Red Oak). One of the trees has severe symptoms of Foliar Chlorosis. Neither tree can be remedied. Also there is an arborist report from a local firm.

## Recommendation

The Environmental Board recommends **approval with conditions** to a variance Land Development Code 25-8-341 to allow cut up to a maximum of 8.2 feet and 25-8-342 to allow fill up to a maximum of 10.3 feet.

### City of Austin staff conditions:

- 1. Areas of cut and fill will be revegetated with no greater than a 3:1 slope or be structurally contained.
- 2. development will consist of two phases to minimize ground disturbance
- 3. landscaping with 100% native plants from the City of Austin Grow Green Guide
- 4. landscaping 10% above requirements
- 5. 75% of all permanent landscape areas to use drip irrigation system
- 6. Integrated Pest Management Plan
- 7. Bio filtration pond associated with phase 1

## **Environmental Board conditions:**

A registered Professional Geologist shall be on site during excavation of cuts of greater than 5 feet.

#### Rationale

Findings of fact have been met. Critical Environmental Features are being protected by a permanent fence. Site was designed to be graded to require more fill than cut in to reduce the impact to any subsurface features that may be encountered during construction.
