#### 6. NEW BUSINESS

a. Presentation on the African American Cultural and Heritage Facility Art in Public Places Project

Alyson McGee introduced guests, Sandra Harkins, (Planner, City of Austin Neighborhood Housing & Community Development) and Alison Von Stein (Project Manager, City of

Austin Public Works), who provided project background and a presentation of facility design and site plan. Alyson McGee presented project planning AIPP staff has undertaken with stakeholders to date, and the proposed goals, evaluation criteria, and call to artists format based on those planning efforts. The Project Outline will be brought to AIPP panel for approval at Nov. 1, 2010 meeting. Panel Members discussed suggested changes to call language to clarify eligibility, and provided names of potential selection panel members. No action was required.

- b. Presentation and Approval of Artist Selection Process for on North Austin Recreation Center/YMCA Facility
  - Alyson McGee introduced guests, Mark Shruben (Project Manger, City of Austin Public Works), Jessie Temple (Owner's Representative, Benz Resource Group), James Finck (President & CEO, Austin YMCA). Alyson presented Project Outline for discussion and action. Panel Member Osgood made a motion to approve the Project Outline tabling recommendations for potential Selection Panel members to Nov. AIPP Panel meeting. Panel Member Roderick seconded. Panel Chair Puleo made a friendly amendment to provide detailed information in the Call to Artists related to the YMCA's programming, and language changes to clarify goals and priorities. Friendly amendment passed (5-0-0). Initial motion passed (4-0-0).
- c. Discussion and Possible Action on the Seaholm Wall Art in Public Places Project Panel Member Osgood presented draft letter from AIPP Panel to City Council. Panel requested staff consult with City's Legal Department to determine if Panel Members could discuss details from the evaluation panel meetings with City Council Members. Panel Member Legge made a motion to entrust final language of the letter to Panel Member Osgood. Panel Member Castillo seconded. Motion passed (4-0-0). Panel Member Chenoweth had left meeting.
