3. NEW BUSINESS

A. Live Strong Austin Marathon – Discussion and Possible Action

Ms. Frances Hargrove, Special Events Manager with the Austin Transportation Department, introduced event promoter Mr. John Conley and his staff to answer concerns about the marathon. After discussion and a request from the Commissioners to report back to the

UTC on the continued efforts to reach to concerned citizens, on Chair Lanier motion, Commissioner Holbrook-White second, with a friendly amendment from Commissioner Blocker to make sure the public notification process is followed, on a 7/0 vote, the following recommendation was approved: The Urban Transportation Commission recommends that the Live Strong Austin Marathon be defined as meeting the definition of an annual grandfather event by waiving the definition of "route" requirement found in 14-8-15(B) and to allow the Transportation Director to add this event to the list of grandfather events maintained by the Austin Transportation Department."

C. Residential Parking Permit Program – Discussion and Possible Action

Mr. Gary Schatz, Assistant Director of Traffic Management and Mr. Carlton Thomas, Engineer Associate with the Austin Transportation Department, gave an extensive presentation and heard concerns voiced by the Commissioners and citizens in attendance about the proposed changes to the Residential Parking Permit. After discussion and taking into consideration the concerns from citizens, the UTC requested a revision of some of the provisions contained in the proposed program and asked staff to return either in December or January for consideration. **No action taken.**
