- **c. Appliance Recycling Program.** Acting Division Manager Donald Hardee was available to answer Commissioner questions regarding SWS practices regarding the recycling of appliances.

- **b.** CAPCOG Interlocal for the Regional Solid Waste Master Plan. A motion to recommend Council authorize negotiation and execution of an interlocal agreement with the Capital Area Council of Government (CAPCOG) to hire and fund temporary staff for the purpose of performing regional solid waste data collection and analysis to support the City's Solid Waste Master Plan and CAPCOG's Regional Solid Waste Management Plan, was approved on a Commissioner Bob Schafer motion, Commissioner Rick Cofer second an a 6-0-0 vote.
