Goals from 2010 annual work session:

- Encourage homeless shelters and short term/crisis accommodations providers to
  establish an appropriate number of beds that adequately reflects the percentage of
  homeless, single women in Austin. Educate City Council for the need to establish
  suitable short-term crisis accommodations to meet the needs of all peoples
  regardless of their race, religion, gender, sexual orientation or disability.
- 2. Explore what means exist to encourage local developers to fully engage in providing affordable housing options for working poor (200% of federal poverty level) families living in Austin.

- 4. Youth Court Discussion and planning involving and educating the community
