Bicycle and Pedestrian Sub-Committee Urban Transportation Commission Meeting Minutes

1. CALL TO ORDER

- **a.** Austin Complete Streets Discussion and Possible Action Commissioner Schaubert has spoken with a representative of Bike Texas who would like to model and introduce the Complete Streets language. The subcommittee will allow her to work on it. No action taken.
- b. Sidewalk Resolution Discussion and Possible Action Commissioner Holbrook-White would like to set up a conference call with people from the Washington, D.C. area to discuss several topics, including the possibility of having an intern work with the subcommittee to assist with some research. The conference call will be posted as a public meeting. Possible dates include October 18th, October 25th, or November 15th. Commissioner Holbrook-white will add some data to the Sidewalk Resolution and will provide it via email to the subcommittee. No action taken.

a. Bike parking needs assessment.

The subcommittee will revisit the issue of bicycle parking and how the requests for bicycle racks are being sent to the city and to whom. A request to check the bicycle codes and if additional meters will be added for bicycle parking will be sent to the City's Bicycle Program. No action taken.
