**I. Call meeting to order.**

- **Opening remarks and introductions.**

a. Introduction of new case managers. Pete Valdez introduced Kim Capobres and Stacey Yates, new case managers hired to work with frequent offenders.

- b. Ordinances and Jurisdictional Issues in DACC/East Austin Area. Lori Renteria said that 3 council members were interested in her request to have all quality of life ordinances extended to the East Austin jurisdiction of DACC. Lori made a motion to entertain discussion, seconded by Tim Miles. Leah Bojo clarified that Councilmember Shade was only looking at the Sit/Lie ordinance. After discussion, the committee voted in favor of extending the Sit/Lie ordinance to East Austin. Six votes in favor; one opposed.
- c. DAA 10-year Report Follow Up. The committee expressed its wish to send the report to all council members. Charles Locklin said he would do it.
- d. Measures of Progress on Addressing Frequent Offenders. Pete Valdez gave an update on actions the court has taken recently, including working with Caritas on housing. Bill Kelly expressed interest in working with a group to look at performance measures related to frequent offenders. Charles requested that an agenda item be placed to take this up next time.
- e. Using DACC Treatment Funds. The committee discussed funding for extended treatment stays as needed, including 90 treatment through Austin Recovery.
- f. Project Recovery Update. John Lawyer updated the committee on the number of referrals from DACC.
