4. Approval of minutes - December 8, 2010 Commission Regular Meeting

5. Staff Briefings

a. Legislative, Regulatory and Policy update. (Rondella Hawkins) (wp4)

Paul Lewis, Assistant Manager of the City of Austin's Office of Telecommunications & Regulatory Affairs (TARA) report included FCC net neutrality Rules; NATOA and the CAP Act.

b. Grant for Technology Opportunities Program (GTOPs) update. (John Speirs). (wp2)

John Speirs, Program Coordinator with the City of Austin's Office of Telecommunications & Regulatory Affairs GTOPs report included: In grant cycle 2010 two of nine grant recipients have successfully completed the grant. 35 applications received for the 2011 grant cycle. January 20 – Responses to written questions due February 1 – first round of scores due February 17 – Oral presentations are scheduled March 9 – Final awards recommendations are presented to the Commission for a vote.

c. Technology Ascertainment Survey update. (Rondella Hawkins) (wp3)

Rondella Hawkins, Manager of the City of Austin's Office of Telecommunications & Regulatory Affairs reported the survey had been mailed and we received 1% of surveys back. The City TARA Office and the University of Texas are keying the survey into a data base. A report on the survey should be final by the end of March 2011.

d. Request for Proposal (RFP) on public access television management contact update. (Rondella Hawkins) (wp1)

Rondella Hawkins reported the RFP on the public access television management should be out to the public by the end of January 2011.
