- a. Presentation from Austin Connects (Sheena Harden?) (wp3)

Sheena Harden, Director of Communications for Austin Free-Net presented a Power Point presentation. Austin Connects is a partnership between the City of Austin, Austin Free-Net and Skillpoint Alliance. The purpose is to provide information and opportunities for local professionals in support of their programs that provide digital literacy and inclusion. - c. Briefing from Planning & Development Review Department on adherence to the City of Austin's Telecommunications Tower Siting Ordinance. (Lynda Courtney, Discipline Lead over the Site Plan Review) (wp4 & 6)

Lynda Courtney, with the City of Austin Planning & Development Review Department's update included overall requirement for siting towers; conditionally permitted towers (require land use commission approval) and administratively permitted towers. #### 6. Staff Briefings

- a. Legislative, Regulatory and Policy update. (Rondella Hawkins) (wp4)

Paul Lewis, Assistant Manager of the City of Austin Office of Telecommunications & Regulatory Affairs report included: **2011 Texas Legislative** – possible changes to Railroad Commission duties; possible state enacting tax on satellite television; Texas SB 5 lawsuit; Universal Service Fund. **Federal Legislative** – CAP Act going to be reintroduced; SB 135 regarding Internet Tax Fairness Act; Cell Tax Fairness Act.

- b. Grant for Technology Opportunities Program (GTOPs) update. (John Speirs). (wp2)

John Speirs, Program Coordinator; with the City of Austin Office of Telecommunications & Regulatory Affairs GTOPs report included: No changes in 2010 grant cycle. The 2011 grants have been narrowed to 20 applicants out of 35 for oral presentations on February 17, 2011. February 24, 2011 final scores will be tabulated. Grant Recommendations will be brought before Commission for approval on March 9, 2011.

- c. Technology Ascertainment Survey update. (Rondella Hawkins) (wp3)

Mr. Lewis reported that 15,000 Technology Ascertainment surveys were sent out with a response from 1,706 (11% response). Final report target date is end of March 2011.

- d. Request for Proposal (RFP) on public access television management contract update. (Rondella Hawkins) (wp1)

Mr. Lewis reported the RFP on public access television management went out to the public on January 31, 2011; pre-proposed meeting was February 9, 2011; RFP closes on March 3, 2011; will be brought before this Commission on April 13, 2011; new contract begins October 1, 2011.

Mr. Lewis also reported that the City of Austin's No Contact Ordinance states if you are a potential vendor participating in a RFP issued by the City you cannot have direct contact with a Council Member, or City Board or Commission member to discuss the RFP.
