

Project Information

- Project to help with localized flooding
- Flooding is caused by inadequate drainage system





Euclid-Wilson STORM DRAIN IMPROVEMENTS

Parks Board Committee Meeting, January 10, 2011

Use of Gillis Park

- Upgrade a pipe running through the park
- Modify the outfall and water quality pond
- Staging area
- Requires permanent and temporary easements

Parks Board Committee Meeting, January 10, 2011

Impact to Park

- No direct impact to pool, playground or basketball court
- Beach (sand) Volleyball court closed
- Kickball fields moved and reconfigured
- Most trees protected



Drainage Easement

- Drainage easement is permanent
- Easement gives us ability to maintain pipe, outfall and pond
- Limits trees that can be planted over easement
- No walls, buildings or permanent structures over easement



Kickball Fields



Staging Area Needs

- Must be approximately 20,000 S.F. in size
- Most desirable to be within project limits, or be within 1/4 miles of site
- Must be open land

Others Sites Considered

- Vacant portion of San Jose Church property on west side of S. 1st Street between Cumberland and Oltorf
- Vacant portion of St. Ignatius Church property on north side of Oltorf
- Vacant tract at 2602 Wilson Street, just north of Cumberland


