Background

Advantages

- Dissipates storm runoff
- Supports a stable slope
- Biological integrity
- Natural and traditional character



Disadvantages

- Concentrates storm runoff
- Impacts to CEFs (rimrock, bluff)
- Potential for instability & erosion




Background

Advantages

- Absorbs wave energy
- Supports water quality
- Supports biological integrity






Disadvantages

- Wave reflection
- Impacts to CEFs (wetlands)
- Replaces aquatic habitat





Background

Recommended changes to Code and Criteria:

<u>Trams</u>

- Require site plan, Title 25 applicability
- Minimize disturbance
- Maintain existing canopy
- Vegetate to protect slope



Bulkheads

- Non-vertical slope
- Include vegetation
- Use natural materials on exterior

Final Ordinance

Primary changes to ordinance occuring since the Aug 2010 Parks motion to support

- Provide ability to repair and maintain non-complying structures
- Provide rules to reclaim some land lost to erosion
- Provide exemption for man-made channels

Council Direction

#1 New regulations should not apply to pre-existing, non-complying bulkheads and docks using rules currently in place for non-complying structures

Action: New subsection (D) in Section 25-2-963 (*Modification and Maintenance of Non-complying Structures*)

Provisions for:

- modification
- repair
- reinforcement
- maintenance



Council Direction

#2 Site plan exemptions should apply for repair, alteration and maintenance

Action: New subsection (L)(5) in Section 25-5-2 (Site Plan Exemptions)

Provisions for:

- repair
- reinforcement
- maintenance



Council Direction

#3 Recapture section should allow repairs that extend into the water to protect vegetation and stabilize property

Action: New subsection (D) in Section 25-2-1174 (*Structural Requirements*)

Provisions to restore land eroded within the previous 10 years (not to exceed subdivided lot line) with documentation






Status of ECM Stakeholder Process

Process to date

Sep 2010 Draft ECM provided to list of interested stakeholders with request for comment


- Oct 2010 Internal (City Departmental) stakeholder meeting
- Nov 2010 External stakeholder meeting
- Jan 2011 Draft ECM posted for public comment, Mailed notification to 2,593 stakeholders, Emailed registered stakeholders Emailed notification to Env Board and Parks Board, Held a supplemental public stakeholder meeting
- Feb 2011 Public comment period closed

Mar 2011 Provide response to stakeholder comments



Environmental Criteria Manual Section 1.13.0

1.13.6 Design and Material Requirements

A. Non-vertical slope

"on or adjacent to shoreline" = wave action zone



B. Protect from overtopping, flanking, toe scour

C. Vegetation (planting criteria)

D. Materials (exterior of natural materials)
