## 2. APPROVAL OF MINUTES

#### SUSTAINABLE FOOD POLICY BOARD MINUTES

Member Ronda Rutledge made motion to accept October 25, 2010 Minutes. Member Arthur D'Andrea seconded the motion. Member Paige Hill abstained as the new board member. Vote of 8-0.

Member Allison Beadle made motion to accept February 14, 2011 Minutes. Member Marla Camp seconded the motion. Members Paige Hill abstained as a new board member. Vote of 8-0.

# F. Presentation of Supplemental Nutrition Assistance Program (SNAP) participation data for Travis County (by Arthur D'Andrea)

Member Arthur D'Andrea presented on how the Travis County has 47% of SNAP participants versus San Antonio has 70-80% participants which is about \$152 million not circulating in the Travis County economy. No action taken.
