Motion by Mayor Pro Tem Martinez to approve the Minutes of the meeting held on July 22, and July 23, 2010. Second by Council Member Morrison. Motion unanimously carries.

- 4. Review proposed revisions to Section 9-4-14 of the City Code, SITTING OR LYING DOWN ON PUBLIC SIDEWALKS IN THE DOWNTOWN BUSINESS AREA PROHIBITED, and take appropriate action. (David Lurie, Director, Health & Human Services Dept., and Vince Cobalis, Assistant Director of Human Services, Health & Human Services Dept.) There were many speakers for and against that spoke including Richard Troxell and Chief Art Acevedo. The Downtown Austin Alliance and Austin Police Department spoke in favor of leaving the Ordinance as is. The Homeless Coalition spoke in favor of changes to the Ordinance.

 Motion by MPT Martinez to accept Ordinance changes to E (2) and E (7), not E (1), of Chapter 9-4-14, seconded by Council Member Morrison unanimously passed
- 5. Report by Austin Energy on the implementation of policies protecting vulnerable customers during extreme weather conditions (Jawana Gutierrez, Customer Care Vice-President, Austin Energy)

 AE staff discussed protection policies for at risk customers. MPT Martinez asked to have the number of disconnections averted due to the new policy.
- 6. Status Report on Implementation Plan to Reduce Animal Intake and Increase Live Animal Outcomes and Take Appropriate Action (David Lurie, Director, Health & Human Services and Bruce Mills, Acting Assistant Director, Animal Services, Health & Human Services Dept.)

 Staff gave an update on the progress of the animal services Implementation Plan.

7. Discussion and possible action regarding the Social Services Request for Proposals (RFP) process: RFP documents, Evaluation Matrix, Transition Plan. (David Lurie, Director, Health & Human Services Department, and Vince Cobalis, Assistant Director of Human Services)

Motion made by Council Member Morrison, seconded by Council Member Shade, we support the recommendations by staff with the motions, modifications and comments that Council Members made, unanimously passed.

Motion by MPT Martinez to change the matrix scoring to 3.5 and 3.0 in categories four and five, respectively, seconded by Council Member Shade passes 2-1.

- On the issue of Outcomes, between now and the 30th would like to get input about demographic outcomes related issues as they are spelled out in the RFP, they might allow for minor modifications.
