# Call To Order: 7:15 P. M.

#### 1. Citizen's Communications

The first four (4) speakers signed up to speak will each be allowed four (4) minutes to address their concerns.

Ms. Jane Hayman spoke regarding the historic designation process revisions.

Ms. Natalie Hernandez spoke regarding her house at 1910 E. 16<sup>th</sup> Street, which was on the September 28, 2009 Historic Landmark Commission meeting; she has been directed by the City of Austin to repair or demolish her house; she had someone who was supposed to do the remodel on the residence, however that person is not able to do the work and asked the Commission for guidance.

Mr. Steve Sadowsky responded that the Commission initiated a historic zoning case on Ms. Hernandez' property on September 28, 2009, but never made a recommendation. Staff reported that they are currently working on a survey for a potential local historic district in the area bounded by 12<sup>th</sup> Street, Martin Luther King, Junior Boulevard, Chestnut Street and Chicon Street, which will include Ms. Hernandez' property. Once the Local Historic District is established, Ms. Hernandez will be eligible for a property tax freeze for the rehabilitation of the house at 1910 E. 16<sup>th</sup> Street. Mr. Sadowsky reported that he had arranged for a waiver of fees and penalties on the property for Ms. Hernandez and would continue to work with her to develop options to demolition of the house.

Commissioner Arriaga suggested that if Ms. Hernandez desires to proceed with the demolition that the case returns to the Historic Landmark Commission.

#### 2. Briefing To The Commission on The Planning and Development Review Department Proposed FY 2011 Budget

Mr. Greg Guernsey, Director, Planning and Development Review Department read the department's mission statement and reviewed the year 2010 budget. Mr. Guernsey stated that the budget includes the Comprehensive Plan Update (the last one was in 1989), anticipated completion date the end of next year. The Planning and Development Review Department is currently working on four northeast neighborhood plans: North Lamar, Georgian Acres, Heritage Hills and Windsor Hills. Mr. Guernsey also gave progress reports on other activities of the Department, including the Downtown Plan, residential demolition permit reviews, the East Riverside Corridor Plan, , the Waller Creek Plan, and the annexation plan. The One Stop Shop will hold a Land Development Academy for staff and the public. The Department is also working on Commercial Design Standards. The Department budget is \$19.6 million, which covers 311 staff members, including 16 CAMPO staff, and 250 employees in the One Stop Shop. Anticipated increases to the FY11 Budget are \$778,000 for insurance, and \$41,000 for miscellaneous expenses. Input is requested from the Historic Landmark Commission by the City Manager, Marc Ott. City Council will hear the Budget on July 28, 2010, Public Hearings will be held on August 4, 2010 and August 25, 2010; budget readings will be held on September 13-14, 2010.
