## 1. CITIZEN COMMUNICATION

## 3. OLD BUSINESS:

# DISCUSSION AND POSSIBLE ACTION ON THE FOLLOWING:

a. Update on African American Cultural Heritage Facility (Sandra Harkins, Neighborhood Housing & Community Development Department)

Ms. Harkins presented the architect's rendering of the completed facility.

b. Presentation of the staff recommendation for the artist and alternate artist for the African American Cultural Heritage Facility Art in Public Places Project (Meghan Turner, Acting Art in Public Places Administrator)

Ms. Turner discussed the artist selection process for the facility and informed the Commission of the selection of an artist and alternate. Mr. Reginald Charles Adams was selected as the artist and Mr. Forest Young was selected as the alternate.

c. Commission recommendation of artist and alternate for the African American Cultural Heritage Facility Art in Public Places Project

A motion to approve the artist and proposed artwork to create an Art in Public Places project for the African American Cultural and Heritage Facility was made by Commissioner Linder, seconded by Commissioner Harden. Approved 4-0 with Commissioner Smith off the dais.

d. Discussion on outcome of January 30, 2010 Community Forum (Rebecca Giello, Neighborhood Housing & Community Development Department)

Ms. Giello reported on the success of the Neighborhood Housing & Community Development Dept with their work relating to the African American Quality of Life Initiative. Ms. Giello provided a detailed report to the Commissioners covering initiatives assigned to the Neighborhood Sustainability Committee.

e. Recommendation to City Council on funding for the African American Youth Resource Center

A motion to recommend that the City Council direct the City Manager to provide funding in the amount of \$270,000 over three years to support an African American Youth Resource Center was made by Commissioner Cook, seconded by Commissioner Linder. Approved 4-0 with Commissioner Smith off the dais.

f. Discussion on outcome of Commission's Retreat held on April 29, 2011

The Commissioners were pleased with the outcome of the retreat and would like to discuss this item more at the July Commission meeting after receiving some additional data at the May and June meetings.

g. Reports from Commissioners on attending other Boards' and Commissions' meetings
