Subject: Director's Report

#### Master Plan Update

The SWS staff Have been editing and upgrading the draft sections of the Master Plan in the past few months. We have consulted with seven Boards and Commissions, with substantial input from the Sustainable Food Policy Board as well as SWAC's input over the past year. The current schedule is as follows:

August 10<sup>th</sup> – SWAC Discussion September 14<sup>th</sup> – SWAC Discussion and Recommendation October 4<sup>th</sup> – City Council Presentation October 6<sup>th</sup> City Council Public Hearing October 20<sup>th</sup> – City Council adoption

#### Trash Dance – Part 2

At the end of this month, Austinites will have the chance to see a unique show involving choreographed garbage trucks, for free! Playing to a sold-out audience of nearly 2000 people upon its September 2009 premier, The Trash Project will ride again for two final encore performances August 27th and 28th.

Directed by choreographer Allison Orr with an original score by Graham Reynolds, The Trash Project is a unique partnership between an Austin arts organization and a City of Austin department. Explains SWS Director Bob Gedert about the 2009 premier, "The Trash Project showcased our employees in a way that had never been done before. "[It] helped boost employee pride and morale and garnered lots of positive media attention for the department." Austin City Council Member Laura Morrison says, "The Trash Project is one of the most unique and inspirational productions I have seen. Allison Orr, with Forklift Danceworks, produced a creative ballet on a grand scale that introduced the audience to the real beauty in the work of our Solid Waste Services employees."

August 25<sup>th</sup>: "Conduct a public hearing to receive public comment on the Solid Waste Services proposed rate and fee changes as part of the Fiscal Year 2011-2012 Proposed Budget."

September 22<sup>nd</sup>: "Set a public hearing to receive public comment on Solid Waste Services Department Master Plan."

October 6<sup>th</sup>: "Conduct a public hearing to receive public comment on Solid Waste Services Department Master Plan."

#### 21 Gallon Carts

SWS is requesting council approval in the SWS FY12 budget to offer a 21 gal trash cart. Proposed rate is 4.00 per month.

#### National Recycling Coalition – update

The National Recycling Coalition has been involved in drafting a US Senate Resolution in support of Recycling. In the next week, Senator Carper (D-DE) and Senator Snowe (R-ME) will be introducing the Senate Resolution regarding support for recycling. The NRC Board of Directors approved the final version of the resolution on Wednesday, July 27<sup>th</sup>. An excerpt of the Resolution states:

Now, therefore, be it *Resolved*, That the Senate—

(1) expresses support for improvement in the collection, processing, and consumption of recyclable

material throughout the United States in order to create well-paying jobs, foster innovation and investment in the United States recycling infrastructure, and stimulate the economy of the United States;

(2) expresses support for strengthening the manufacturing base in the United States in order to rebuild the domestic economy, which will increase the supply, demand, and consumption of recyclable

and recycled materials in the United States;

(3) expresses support for a competitive market place for recyclable materials;

(4) expresses support for the free and fair trade of recyclable commodities, which is an integral part of the domestic and global economy;

(5) expresses support for policies in the United States that promote recycling of materials, including

paper, which is commonly recycled rather than thermally combusted or sent to a landfill; (6) expresses support for policies in the United States that recognize and promote recyclable materials as essential economic commodities, rather than wastes;

(7) expresses support for policies in the United States that promote using recyclable materials as feedstock to produce new basic materials and finished products throughout the world;

(8) expresses support for research and development of new technologies to more efficiently and effectively recycle materials such as automobile shredder residue and cathode ray tubes;

(9) expresses support for research and develop ment of new technologies to remove materials that are impediments to recycling, such as radioactive material, polychlorinated biphenyls, mercury-containing devices, and chlorofluorocarbons;

(10) expresses support for Design for Recycling, to improve the design and manufacture of goods to ensure that, at the end of a useful life, a good can, to the maximum extent practicable, be recycled safely and economically;

(11) recognizes that the scrap recycling industry in the United States is a manufacturing industry that is critical to the future of the United States;

(12) expresses support for policies in the United States that establish the equitable treatment of recycled materials; and

(13) expresses support for the participation of households, businesses, and governmental entities in the United States in recycling programs, where available.


