## Hello Sandra and All,

I totally agree with Lisa's statement. It's sort of an exercise in frustration to pull people, who are already very busy doing whatever they do, together to come up with ideas to improve public property only to tell them, "We do not have any resources for this." We give our time and input because we care about what happens on East 11th, in our neighborhoods, and in our city. So, Sean and Sandra, thank you for arranging things and thank the URB for wanting to know what people would like to see happen.

But, we did a little brainstorming a year ago and then some of us have gotten broader community input while others, mostly Harold, have developed ideas to expand current efforts. But, we were effectively reminded yesterday that, "It's up to you folks to make things happen." That's not true, or fair, or realistic. Try to imagine me getting my neighbors together, asking them for ideas on how to fix up my run down property, and they do that because they want the neighborhood to look better. And then I tell them, "Okay, it's up to you, my good neighbors to get the money together and fix up my property." That's plain wacko.

Sandra, I would suggest that, if your job is to report back to URB on "ideas", then I think you're more or less finished gathering input unless you or someone appointed by URB goes to the most impacted neighborhoods, business and arts groups and OCEAN and gathers more "ideas". Please be sure to let URB know that we all have other work we're doing and, as much as we would like to see improvement on Block 18, none of us have much additional time and no significant resources to implement ideas. They are the "owners" and, even though Harold has a lease, they should be "slum lords",. literally in this case being as how that block has been declared part of a slum and blight. It is the job of the URB and City to implement improvement for the area, so they should be creatively and actively working on that (and we all see that efforts have been made).

Obviously, Harold has a lease and that needs to be given high consideration. He has been doing things on the block and has ideas for going forward. As I mentioned yesterday, I think his latest ideas need a little more vetting, but, at least those have some momentum. They are based more in "reality" than the "concept" we tossed together in a couple hours over a year ago and I think the focus should be on his proposal.

Finally, I reiterate Lisa's conclusion that it is the property owner's responsibility to bring the property up to some sort of respectable standard, especially when the owner is a public entity, and even more especially when that public entity is charged with seeing that blighted areas are improved.

Simply getting ideas from people who care, followed by telling them, "We don't have any resources to make those ideas come to fruition," is not going to satisfy anyone.
