1. LDC Section 25-8-454(D) (1) (a)] To exceed the 20% impervious cover limit for the site.

2. LDC Section 25-8-454(D) (2)] At least 40 percent of a site must be retained in or restored to its natural state to serve as a buffer, the buffer must be contiguous to the development, and the buffer must receive overland drainage. Use of the buffer is limited to fences, utilities that cannot reasonably be located elsewhere, irrigation lines not associated with wastewater disposal, and access for site construction.

Board Conditions: Applicant remove impervious cover to bring site to below 40% Impervious cover and construct the Water Quality Pond.
