COMMITTEE BUSINESS

The Committee voted to support the City Manager's Proposed 2006 Bond Appropriation/Sale Schedule with the following recommendations:

Prop 1

\$6 million in additional funding should be identified over the next 3 years for new sidewalks.

Prop 3

Whenever possible, PARD should pursue shade "opportunities" (trees, structures, sails, etc) adjacent to pools

Prop 5

Neighborhood Housing and Community Development (NHCD) should confirm their best efforts in canvassing the nation for innovative solutions to the challenge of delivering affordable housing to Austin with limited funding. The top 25 cities in the country have the same challenge as Austin does. How are they stretching their dollars?

Chair Beverly Silas agreed to have a memo to City Council completed no later than June 13, 2008. Shelley Kilday reported that she would send a summary of their recommendation to the CIP subcommittee of the Planning Commission in time for their Wednesday June 4 meeting.
