

# SEATAG HISTORY

- South East Austin Trails and Greenways Alliance
- Founded in 2004 during the East Riverside/Oltorf Combined (EROC) Neighborhood Plan process
- Members are neighborhood residents, area businesses, apartment owners, CoA Neighborhood Planning and Public Works employees, volunteers organizations
- Affiliate of Austin Parks Foundation
- Received Keep Austin Beautiful Community Involvement Award 2006
- Donations from area businesses total over \$36,000
- Cleared brush and trash from park, paved over 1 mile of trail, installed signs, built bridge
- Negotiated with land owners for easements

# WHAT HAS SEATAG ACCOMPLISHED?

- Cleared brush, acquired easements, paved trail through Guerrero Park to Elmont Drive.
- Sponsored clean up days since 2005 to pick up trash in Park and Creek.
- Coordinated efforts of thousands of volunteer hours from UT, ACC, St. Edwards, Boy Scouts, KAB, APF volunteers
- Raised over \$36,000 from Spansion, APF, Tokyo Electron in money and donations
- Successfully petitioned Council for assistance with easements

- 1/2 mile of trail paved, two Dumpsters filled, invasive plants removed



# Country Club Creek Springs Preserve



## **WHY THESE PROPERTIES ARE IMPORTANT**

- They contain the environmentally sensitive headwaters springs of the creek
- They will create a pocket park for the surrounding neighborhoods and apartments
- They are part of the EROC Neighborhood Plan to create a trail and greenbelt, and protect the headwaters of the Country Club Creek
- The EROC area has the highest population density in the city, and the least green space

# WHY INVEST HERE?

- SEATAG and APF have a consistent history of creating alliances for building and maintaining park properties in this area
- This area needs more public open space
- The headwaters springs of Country Club Creek need to be protected
- These properties are part of the EROC master plan created by the neighborhoods
- This is the opportunity to buy properties during the real estate downturn
