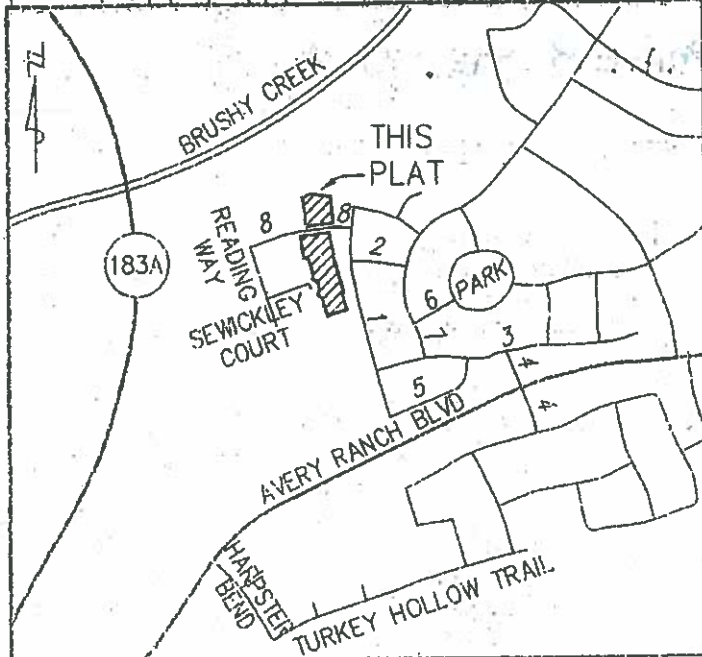

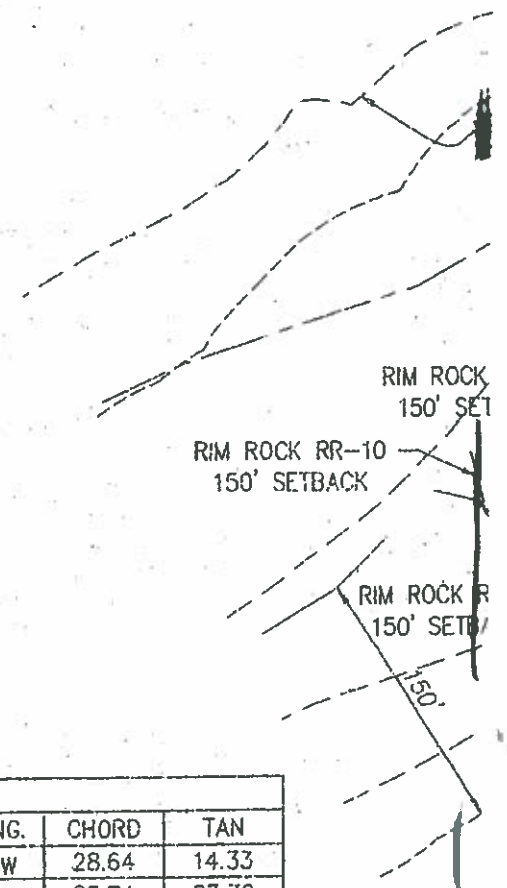


- 1 RUNNING BRUSH LANE
