- **C.** Potential Code Amendments Proposed for Initiation and Other Presentations These potential amendments to the code are offered for discussion and possible recommendation for initiation. If initiated, staff will research the proposals and report back to the committee.
  - 1. **Mixed Use and Compatibility** Discussion and possible action on an ordinance related to Mixed Use overlay districts and compatibility standards. (Commissioner Dealey)
  - 2. **McMansion** Discussion and possible action on an ordinance to amend the McMansion regulations as they relate to attics and floor area calculations.. (Commissioner Dealey)
  - 3. **Cocktail Lounges in Rainey Street** Discussion and possible action on an ordinance to make Cocktail Lounge a conditional use in the Rainey Street District. (Commissioner Sullivan)
  - 4. **Heritage Tree Ordinance** Discussion and possible action on an ordinance to amend the Heritage Tree Ordinance (Commissioner Sullivan)

North Burnet Gateway (Two Story Minimum) Discussion and possible action on an ordinance to provide clarification to the definition of "two-story" and provide flexibility in the code to accommodate projects which may not be able to meet a full two-story requirement, i.e. civic uses, projects in which the site constraints will not allow for a two-story minimum, or projects where there is a community benefit to providing a one-story

- 6. North Burnet Gateway (Sign Regulations) Discussion and possible action on an ordinance to amend provisions of the North Burnet Gateway District sign regulations. NBG currently references the UNO sign regulations that are applied based on specific roadways i.e. Rio Grande and Guadalupe. These roadway names are not consistent with the roadways within the North Burnet/Gateway. - 7. North Burnet Gateway (Subdistrict Map) Discussion and possible action on an ordinance to clarify the boundaries of the North Burnet Gateway subdistricts. The Ordinance No. 20090312-35 establishing the North Burnet/Gateway (NBG) Zoning District and adopting the Regulating Plan does not include the North Burnet/Gateway Subdistrict Map as an exhibit. Because the Subdistrict Map is not included as an exhibit in the ordinance, updating the Subdistrict Map within the Regulating Plan document. Amend ordinance NO. 20090312-035 to provide a mechanism that allows the Subdistrict Map to be updated within the Regulating Plan when a zoning change takes place amendment (Staff Contact: Christine Freundl, Planning and Development Review Department, 974-2868, Christine.Freundl@AustinTexas.gov).

North Burnet Gateway (Water Quality Control) Discussion and possible action on an ordinance to amend Section 4.11.3 (A) of the North Burnet/ Gateway Regulating Plan related to Water Quality Control in the Urban Watershed. Currently, Section 4.11.3 (A) of the NBG Regulating Plan references Section 25-8-92 (C) of the Land Development Code. Section 25-8-92 (C) refers to Critical Water Quality Zones at the shorelines of Lake Travis, Lake Austin, and Town Lake. Section 25-8-92 (E) of the Land Development Code refers to Water Quality Control in the Urban Watershed.
