

DOWNTOWN COMMISSION MINUTES

REGULAR MEETING WEDNESDAY, NOVEMBER 16, 2011

The Downtown Commission convened in a regular meeting on Wednesday, November 16, 2011, at 301 W. 2nd St. in Austin, Texas.

Chair Mandy Dealey called the Commission Meeting to order at 5:36 p.m.

1. CALL TO ORDER AND INTRODUCTIONS

3. APPROVAL OF MINUTES

The minutes from the October 19, 2011 meeting were approved on an 11-0-2 vote on Commission Member Haas' motion, Commission Member Sher's second, with Commission Members Fernandez and Whatley abstaining.

Paul Snyder of the Travis Central Appraisal District briefed the Commission on how heritage trees might impact the value of downtown properties.

Keith Mars, City Arborist, briefed the Commission on the heritage tree ordinance.
