Authorize award and execution of Amendment No. 1 to a 36-month contract with FM973 PIT MATERIALS for spoils disposal services for the Public Works Department for debris generated by street repair and maintenance activities in an estimated amount not to exceed \$32,000 for the first 12-month extension option and two additional 12-month extension options in an estimated amount not to exceed \$32,000 per option, for a revised total estimated contract amount not to exceed \$192,000.

Amount and Source of Funding

Funding in the amount of \$21,333 is available in the Fiscal Year 2011-2012 Operating Budget of the Public Works Department. Funding for the remaining extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract with FM 973 Pit Materials, Del Valle, TX, provides for spoils disposal landfill services for Public Works Department, Street & Bridge Operations for the disposal of spoils material generated by the street maintenance activities. Spoils material (not sewage contaminated material) include debris such as flexible base, hot mix asphaltic concrete, concrete, asphalt millings, soils, vegetation, rock, and other debris generated from street repair and maintenance activities.

This contract was competitively bid and awarded in 2008. This recommended Council action is to approve Amendment No. 1 for \$32,000 for the first 12-month extension option and the authorization to enter into the final two option periods for \$32,000, when appropriate, for a final contract value of \$192,000.
