Dear City Council Members,

In its meeting on July 20, 2011 the Downtown Austin Community Court Advisory Committee was presented with a presentation by APD Officer Taber White titled "Crime Analysis of Neighborhoods Surrounding 12th St./Chicon".¹ Upon completion of the presentation, several residents of the area spoke to us about crime they witness on a regular basis and asked that we explore expanding the boundaries of the Downtown Austin Community Court Eastward to include the area of 12th and Chicon Streets. The Committee was also presented with several emails from residents of the area.²

The Committee subsequently passed a motion requesting City Council to direct City staff to study the resources that would be necessary in order to expand the DACC jurisdiction to include 12th and Chicon.³

As the Chair of the Committee, it is my belief that the Court does not currently have the adequate resources to expand the jurisdiction of the DACC nor am I completely convinced that most of the crime in this area could be resolved by DACC expansion as most of the crime is truly criminal in nature.

That said, however, it was very clear from the testimony given that the area needs a great deal of help in fighting crime and does have a high homeless and loitering population breaking quality of life ordinances and therefore expansion of the DACC maybe a good start. In order to do so, however, the appropriate resources would need to be applied to the DACC budget to make this an effective reality.

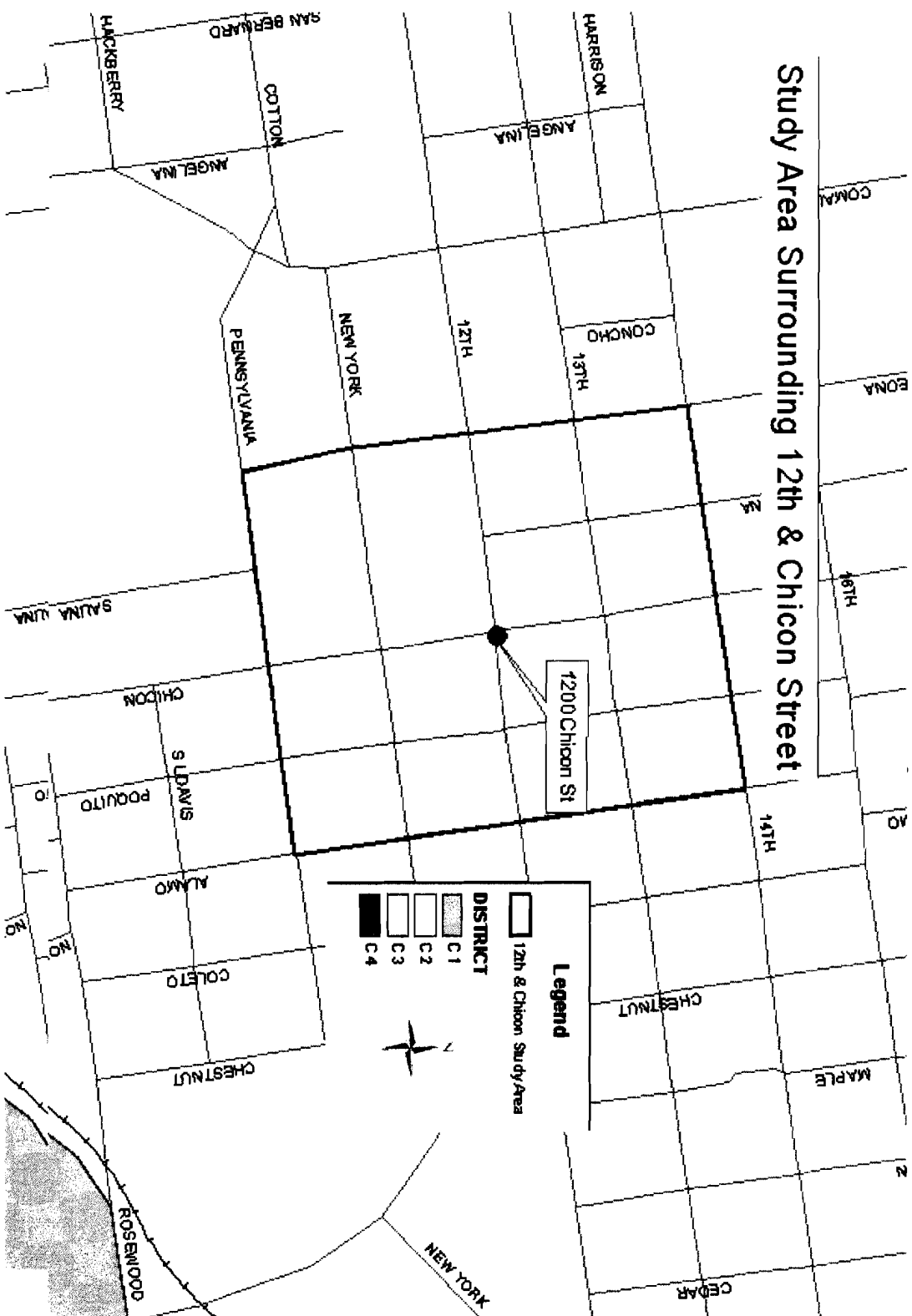

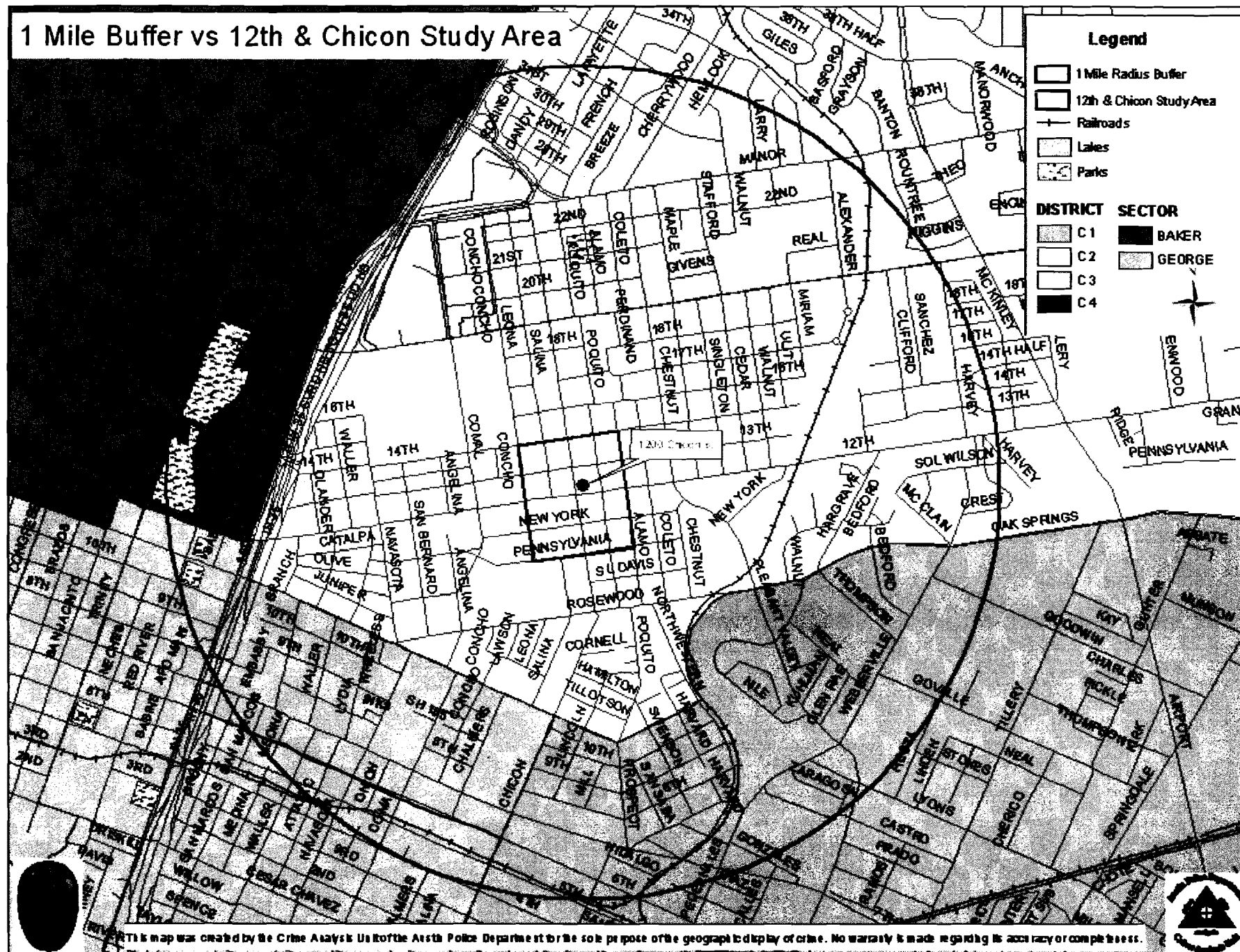

Study Area Surrounding 12th & Chicon Street



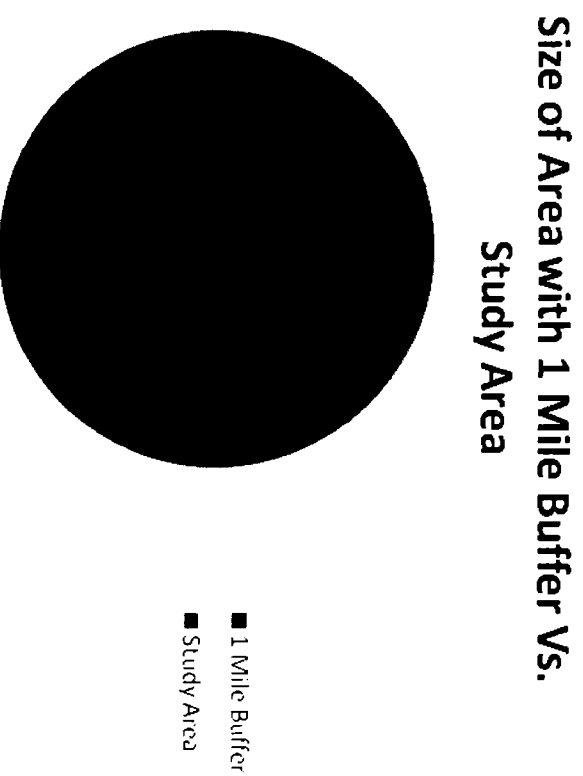
1 Mile Buffer vs 12th & Chicon Study Area

Size of Study Area

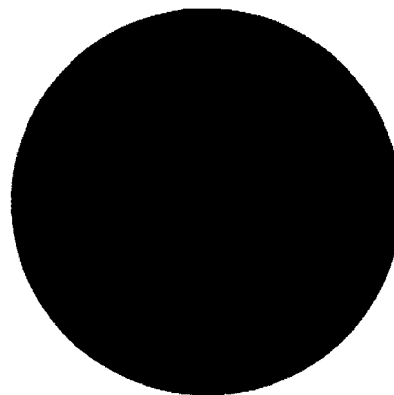
- Area within 1 mile buffer (3.141 square miles)

Number of Calls in Study Area

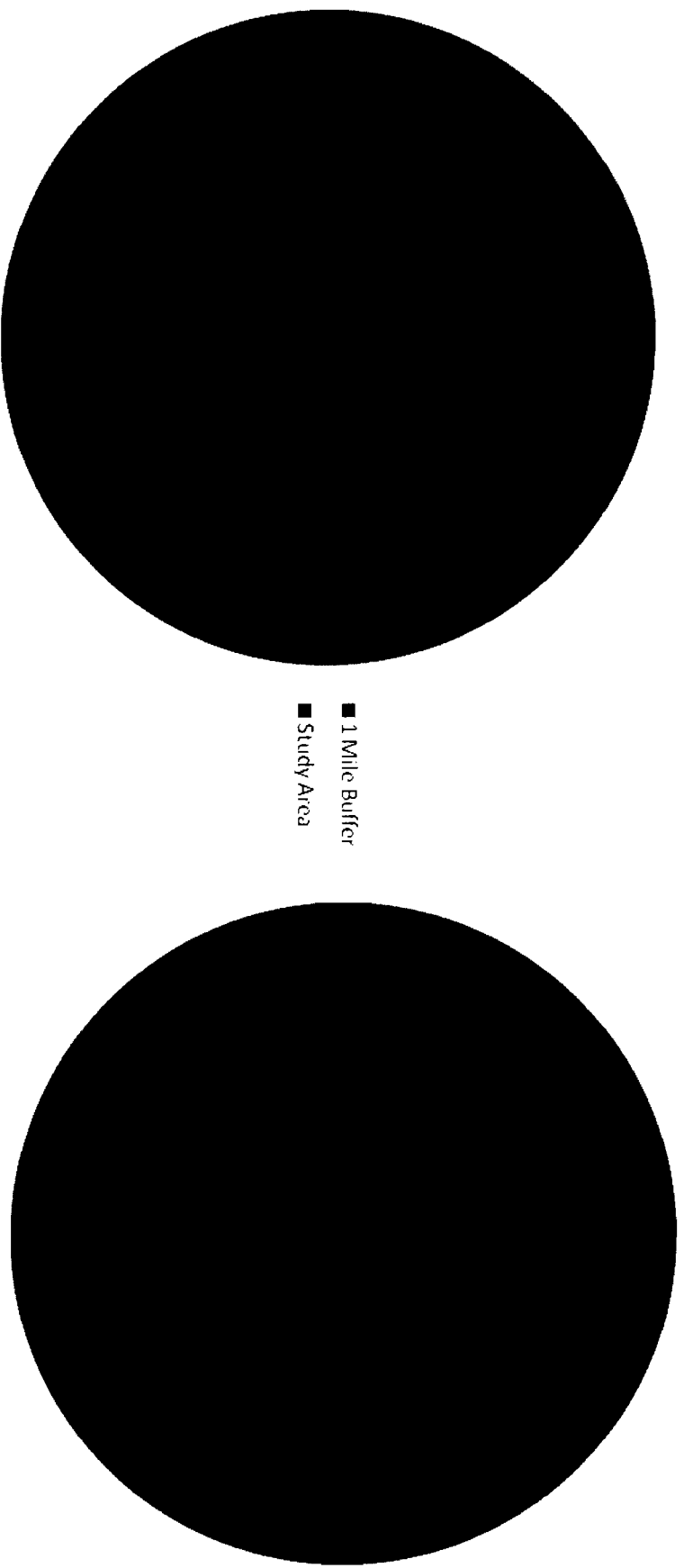
- Within Buffer: There were 8,011 total reported incidents in the 1 Mile Buffer from 1200 block Chicon Street. (88.13%)

■ Study Area

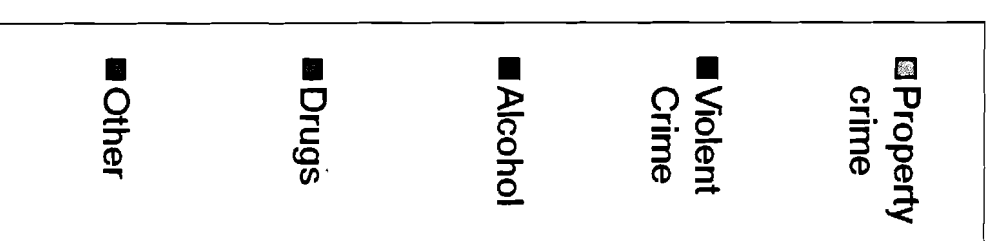
Comparison: Area Vs. Incidents

Dear Ms. Renteria and Officer White:

It has just come to our attention that you will soon be meeting to discuss extending the jurisdiction of the Downtown Austin Community Court and the enforcement area of the No Sit/No Lie ordinance. We are writing to request that these areas be extended to include our neighborhood--East 12th Street to MLK, I-35 to Comal--and that you consider extending the jurisdiction to East 12th Street from I-35 eastward to Chicon.

Since we only learned of this possible effort yesterday, we have not yet had a chance to sit as a neighborhood group and discuss this issue. But with certainty I wanted to let you know that the idea of extending this ordinance to our neighborhood and the 12th Street corridor has been on our "want list" for several years.

Therefore, while we take a bit of time to coalesce around this issue (particularly given that it is summer and several board members are out of town), we would like to request that we be included in the expanded jurisdiction of DACC.

Additionally, we would like to remind you that such proposed actions have an enormous impact on all of the neighborhoods of Central East Austin. Thus, we are confident that several other of these neighborhoods would also like their areas to be included in any expanded jurisdiction. And we respectfully request that you include all of the OCEAN neighborhoods in your plans and any continuing dialogue surrounding this issue. (I have copied Stan Strickland, President of OCEAN.)

Dear Members of the Downtown Austin Community Court,

My name is William Moner and I am a resident of East Austin. I am writing to ask for your support in extending the "no loitering" laws to the area directly surrounding 12th St. and Chicon Ave. in East Austin.

My wife and I have lived here for a little over a year and have renewed our lease because we enjoy living in this neighborhood. We enjoy taking my young son for walks around the neighborhood surrounding Garza High School and areas closer to Manor Road. Unfortunately, we confine our activities in the neighborhood to the areas north of 14th Street due to the unsafe conditions presented by the constant loitering and obvious illegal activities occurring at all hours in the 12th and Chicon area of East Austin.

To be blunt, I fear for the safety of my family in the 12th and Chicon area of the neighborhood. On several occasions, I have had to stop my vehicle to avoid hitting people wandering aimlessly into the roadway. I have had people stop me to ask where they could buy drugs in the area. I have witnessed drug deals occurring on the side streets and in alleys. To me, this is unacceptable.

I believe in the freedom of people to congregate within the limits of the law. Clearly, those congregating in the area are endangering motorists, cyclists and pedestrians in the area. I ask the Court to consider extending the no loitering laws so that those traveling in the area can feel safe and those who live in the area can be proud of the neighborhood. Furthermore, I would love to see the storefronts in the area open with new small business opportunities. Economic growth is severely limited by the constant presence of illegal drugs and prostitution in the area.

Enacting "no loitering" laws would be a welcome first step in making the community a safer place to live.

To Whom It May Concern:

Since 2005, my wife and I have owned and operated three small rental houses just north of 12th street: 1207 and 1209 Salina and 1801 E. 13th. I am a state government employee and my wife is a real estate agent; this is a small side business for us. We have worked hard to be good landlords and to provide safe, clean, affordable housing for our tenants.

In the past year we have been alarmed at an increase in theft, drug solicitation and other security problems. These seem to be connected with an increase in pedestrian traffic and "loitering" on Salina Street, and especially in the alley just south of our 1207 Salina house that runs perpendicular to Salina. There have always been people congregating on Salina, but in the past year something escalated and we began to have serious problems affecting our tenants. We began to see stolen bicycles, ladders, window unit air conditioners and more. Regarding alley traffic adjacent to 1207 Salina, in May one of our tenants reported "We were woken up at around 8:00 this morning to a fight when someone was slammed into the side of the house. Shook the whole thing!"

The upshot is that for the first time, in 2011 we have had tenants move out of our units because of security concerns. This has happened twice with two different tenants, once at 1207 and once at 1209 Salina. Both incidents resulted in lost time and income for us, not to mention lost peace of mind for us and our tenants. We have never had a problem with tenant turnover—until this year.

We have done our best to work with the Austin Police Department to address the problem. I met personally with officer Antoine Tarver, our previous neighborhood contact, and we signed trespass forms that would allow APD to come onto our property and question or arrest trespassers at any time. So far, while APD has made a good faith effort, continuous public traffic and "loitering" on the street and in the alley has made it almost impossible to effectively address the problem with a law enforcement approach that involves responding to individual incidents.

We would strongly support a loitering ordinance that gives police the authority to keep the streets clear of vagrants and others who do not live in housing on our street. I would be happy to answer any questions relating to this matter.

Dear Chair Locklin, Downtown Austin Community Court Advisory Committee Members, and Officer White,

Last week I learned that your Advisory Committee will be meeting Wednesday, July 20, 2011, to, in part, discuss and possibly recommend the expansion of the jurisdictional boundaries of the Downtown Austin Community Court (DACC) in a configuration that will include the E. 12th and Chicon Street area. I and the Central East Austin communities and neighborhoods welcome and thank you for that effort. I also strongly urge that in the event you decide to do so, you include, at a minimum, the entirety of the neighborhoods that comprise the Organization of Central East Austin Neighborhoods (OCEAN) - those that feel the brunt of the crime and vagrancy associated with the E. 12th and Chicon Streets intersection.

As most Austinites know, the area in the immediate vicinity of the intersection of East 12th and Chicon Streets has for decades plagued Central East Austin as a very active haven for drug deals, prostitution, and criminal vagrancy. The status quo and continued tolerance of the criminal activity at that intersection is not acceptable! Many of the Central East Austin residents will attest to the criminal activity that spills from that intersection into their adjacent and nearby streets, schools and backyards. Any increased focus to eliminate the ongoing crime, without taking a holistic approach to expand the DACC's jurisdictional boundaries to include, at a minimum, the OCEAN area neighborhoods, will cause the criminal activity to persist and migrate deeper into the neighborhoods.

Again, we in Central East Austin welcome the DACC's approach to supplement the traditional Municipal Court system's efforts in addressing the Class C

Misdemeanor offenders. More times than not, the revolving door of the current criminal justice system returns individuals to our streets after a short period of incarceration without addressing their underlying problems. Without meaningful, effective, and appropriate assistance, rehabilitation, and punishment, this process inevitably results in the same individuals appearing in our neighborhoods, loitering, panhandling, and committing the same crimes over and over.

Thank you for your consideration and efforts in addressing this problem. I look forward to working with you on this very important issue. If you have any questions, or if I can be of any assistance to you, please do not hesitate to contact me.

To the City Council of Austin,

I have lived in Austin for 12 years and 8 of those years have been in my home on east 13th street. My wife and I love our neighbors and we take great pride in being part of our neighborhood. Recently, several members of the Austin police department have taken the initiative to reach out to local residents to gauge if there is public support when it comes focusing more energy and attention on our neighborhood. We support APD in doing this and wanted to share just a few of things that my wife, our neighbors, and myself deal with on such a constant basis that we've become almost acclimated to it.

There have been multiple attempts to break into our home. We've had our tool shed broken into and several thousand dollars worth of property taken. We've had chained up bicycles that have been stolen and my car was broken into for less than 2 dollars worth of change. We've had garden gnomes, garden hoses, a Buddha statue, plants, and even a sprinkler head that was actively running stolen. Pretty much anything that can be easily carried off and sold for quick cash is fair game. My wife has even walked out onto the porch thinking that she was greeting me as I came home from work, only to find a complete stranger carrying off our patio furniture. This instance ended in physical altercation.


We witness drug deals and prostitution (both straight and gay) happening on an almost daily basis. Most of this actually happens behind our neighborhood church. We often witness people urinating and defecating in the churchyard.

I've personally intervened to stop a man being beaten severely in the head by two attackers. Every other month, we experience someone either passed out in the yard or hiding in the bushes to avoid someone that is chasing them. My neighbor even experienced such an instance where the individual ran through her house and then broke through the backyard fence. Because of situations like this we now keep a shotgun by the front door.

In all, it's extremely ridiculous what happens in front of our house. Sometimes it's scary. Having a patrol car just sit on the street is a blessing. It guarantees that we won't be woken up at night by people who don't live in the neighborhood (and sometimes not even Austin itself) fighting over a rock of crack or that we have to usher dinner guests back inside because of gun shots being fired a block away.

My name is William Moner and I am a resident of East Austin. I am writing to ask for your support in extending the "no loitering" laws to the area directly surrounding 12th St. and Chicon Ave. in East Austin.

My wife and I have lived here for a little over a year and have renewed our lease because we enjoy living in this neighborhood. We enjoy taking my young son for walks around the neighborhood surrounding Garza High School and areas closer to Manor Road. Unfortunately, we confine our activities in the neighborhood to the areas north of 14th Street due to the unsafe conditions presented by the constant loitering and obvious illegal activities occurring at all hours in the 12th and Chicon area of East Austin.

To be blunt, I fear for the safety of my family in the 12th and Chicon area of the neighborhood. On several occasions, I have had to stop my vehicle to avoid hitting people wandering aimlessly into the roadway. I have had people stop me to ask where they could buy drugs in the area. I have witnessed drug deals occurring on the side streets and in alleys. To me, this is unacceptable.

I believe in the freedom of people to congregate within the limits of the law. Clearly, those congregating in the area are endangering motorists, cyclists and pedestrians in the area. I ask the Court to consider extending the no loitering laws so that those traveling in the area can feel safe and those who live in the area can be proud of the neighborhood. Furthermore, I would love to see the storefronts in the area open with new small business opportunities. Economic growth is severely limited by the constant presence of illegal drugs and prostitution in the area.

Enacting "no loitering" laws would be a welcome first step in making the community a safer place to live.





























