AN ORDINANCE AMENDING ORDINANCE NO. 20070517-064 AWARDING A FRANCHISE TO LONE STAR CAB COMPANY TO ALLOW FOR THE ALLOCATION OF 30 ADDITIONAL TAXICAB PERMITS, AND TO DEFE PART 4 RELATING TO TAXICAB FRANCHISE OWNER REQUIREMENTS.
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
PART 1, Part 3 of Ordinance No. 20070517-064, which awards a franchise to Lone Star Cab Company, is amended to read: PART 3. FLEET SIZE.
The franchise holder must maintain an active of fleet of at least 25 and not more than 88 taxicabs. This taxicab allocation may be amended during the course of the franchise. PART 3. Fart 4 of Ordinance No. 20070517-064 is deleted.
PART 3. The franchise holder shall file its written acceptance of the terms of this amendment to its franchise ordinance, Ordinance No. 20070517-064, with the City Clerk no later than May 18, 2012.
PART 4.
