Additional Backup Information

In 1999, City Council passed a resolution intended to ensure that the West Second Street area would support pedestrian and retail-oriented businesses and complement the proposed City Hall as a public destination. The resolution resulted in the reconfiguration of the two Computer Science Corporation (now Silicon Laboratories) buildings to include retail-type spaces on the ground floors and the creation of a plan to recreate Second Street as a pedestrian-oriented downtown retail, residential and restaurant district with wide sidewalks, street trees, and amenities for pedestrian convenience including benches, trash receptacles, and bike racks.

Council approval is now being sought to negotiate an amendment to the existing professional services agreement with Copley Wolff Design Group to provide construction phase services for Phase III, completing the extension of the Second Street District Streetscape Improvements eastward from Congress to Trinity, as approved by Council in July 2001.

Construction is scheduled to begin in April 2012. This project is located within zip code 78704 and is managed by the Public Works Department.
