Authorize award and execution of a 12-month service contract with CLEANSERVE, INC., to provide cleaning, televising and point repair of sanitary sewer collection system pipes for the Austin Water Utility in the downtown area in an estimated amount not to exceed \$362,750, with two 12-month extension options in an estimated amount not to exceed \$362,750 per extension option, for a total estimated contract amount not to exceed \$1,088,250; and with PIPELINE VIDEO INSPECTION & CLEANING, to provide cleaning, televising and point repair of sanitary sewer collection systems pipes for the Austin Water Utility in city wide areas outside downtown in an estimated amount not to exceed \$394,920, with two 12-month extension options in an estimated amount not to exceed \$394,920 per extension option, for a total estimated contract amount not to exceed \$1,184,760.

Amount and Source of Funding

Funding in the amount of \$441,974 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility. Funding for the remaining five months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

Additional Backup Information

The first contract is to provide cleaning, televising and point repair services for sanitary sewer system pipes, ranging in size from 6" to 48" for areas within the down town Austin. The second contract is for the areas outside of downtown Austin is to provide cleaning, televising, point repair services for sanitary sewer pipes ranging from 6" to 96", cleaning of flumes and vortex drop structures. The cleaning process will remove sludge, roots, grease, grit, solids and other debris from the wastewater pipes and adjacent manholes. The contractor must remove the debris from the collection system and not allow it to travel downstream. All solids will be transported and dumped by the Contractor to roll-off containers at the City's Walnut Creek Wastewater Treatment Plant. This contract also includes televising the cleaned sewer mains and coding any defective conditions in the sewer mains on the GraniteXP software. The existing contract does not have any provision for cleaning sewer main larger than 60 inches, flumes structures, vortex structures nor performing point repair on the sewer mains.

PRICE ANALYSIS

- a. Adequate competition.
- b. One hundred twenty notices were sent, including ten MBEs and three WBEs. Four bids were received, with one response from a WBE and no responses from the MBEs.
- c. The scope of work for this solicitation has been changed from the current clean and TV contracts, therefore, there is no cost comparison.

APPROVAL JUSTIFICATION

- a. Lowest bids. CleanServe, Inc. is not the current provider of any cleaning and televising work for the City, and Pipeline Video Inspection, LLC is the current provider for cleaning and televising of small diameter sewer mains.
- b. The Purchasing Office concurs with the Austin Water Utility's recommended award.
