**ORDINANCE NO. 20060727-043**

**AN ORDINANCE INCREASING THE TAXICAB ALLOCATION FOR HARLEM CAB COMPANY, D/B/A AUSTIN CAB.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The city council finds that:

- (A) Ordinance Number 20050609-018 granted a taxicab franchise to Harlem Cab Company, doing business as Austin Cab; and
- (B) the franchise provides that council may amend the taxicab allocation from time to time during the franchise period.


**PART 2.** The taxicab allocation for Harlem Cab Company, d/b/a Austin Cab, is increased from 139 to 159. This increase includes eight permits which were distributed by the Public Works Department on July 14, 2006 in accordance with Section 13-2-327 (*Distribution of Additional Permits*) of the City Code.

**PART 3.** This ordinance takes effect on August 7, 2006.





**DATE:** July 10, 2006

**SUBJECT:** Additional Permits for Austin Cab

During the discussion regarding the Roy's Taxi / Yellow Cab permit transfer, the City Council directed staff to increase the taxicab permit allocation of Austin Cab by twenty (20) permits. Eight (8) of these permits come from the population / airport departure growth factors available in 2006, four (4) permits from the Roy's Taxi franchise, and the remaining eight (8) from future growth in the population / airport departure growth factors.

Public Works will allocate eight (8) additional permits to Austin Cab under the terms of Section 13-2-327 (Distribution of Additional Permits) of the City Code. The City Council will consider an ordinance on July 27, 2006 increasing the taxicab permit allocation of Austin Cab by an additional twelve (12) permits to a total of 159 taxicab permits.

The City Council has directed staff to proceed with the action necessary to increase the taxicab permit allocation of Austin Cab by twenty (20) permits. This item is on the agenda for the Commission's information. Staff will be available to answer questions.

**Item 42 - July 27, 2006**

Approve an ordinance awarding a taxicab franchise to ABCABCO, INC., d/b/a LONE STAR CAB COMPANY, CAPITAL CITY CAB COMPANY or GREEN EAGLES, INC., d/b/a LONGHORN CAB COMPANY, as chosen by lottery pursuant to Section 13-2-309(C) of the City Code, to operate a taxicab service in the City; and waiving the provisions of Section 13-2-309(B) of the City Code establishing the maximum number of permits that may be allocated to a franchise applicant. The taxicab permit fee of \$400 per year per permit is a revenue source. Expected annual revenue is \$22,000.
