Special Work Session 31 January 2012

A. Taxicab Resolution-Update and Possible Action

Staff provided an update as requested and included stakeholder input and UTC's recommendations from the January 10, 2012 meeting. A total of nine citizens addressed the Commission providing comments on staff recommendations to Council, the number of additional permits being proposed to be issued, the need to keep the current formula, taxicab stands, a \$1.00 rate increase, clean-up fee, the importance of maintaining the process fair and with integrity when presenting the recommendations to Council, and other concerns. On Chair Lanier motion, Commissioner Blocker second, on a 4/0/3 vote with Commissioners Demling, Locker, and Holbrook-White absent, the following motion carried:

- The Urban Transportation Commission recommends the issue of 53 taxicab permits to the existing franchise holders and set aside the additional 22 permits to be used for a future franchise;
- Staff to come up with a day lease program;
- Support the \$1.00 per passenger fee after 9:00 p.m.;
- Support the \$100.00 clean up fee;
- Support a sustainable fee initiative but would like to see accessible vehicles as part of the initiative;
- At this point the proposed pilot for legacy permits for 25 permits outside the current formula is unmanageable, insufficient. Staff and UTC members should continue to look for alternative options.
