2. Adoption of agenda.

4. Approval of minutes – February 8, 2012 Commission Regular Meeting.

5. Report from the "Code for America Code-a-Thon" event. (Chip Rosenthal) (wp4)

One of the Code for America Fellows, Aurelio Tinio, summarized the Fellows month in residence talking to City Austin staff and the community about programs, processes and potential web-based solutions and the Code Hack-a-Thon. There was also a report from some of the Hack-a-Thon participants.

6. Staff briefing on Legislative, Regulatory and Policy update. (Paul Lewis) (wp5)

Paul Lewis, Assistant Manager of the City of Austin Office of Telecommunications & Regulatory Affairs, Legislative, Regulatory and Policy update included; INet deactivations from Time Warner; PEG channels coordination for equipment purchases; Stop Online Piracy Act (SOPA); FCC Reform Act Legislation; FCC Basic Tier Encryption NPRM; H.R. 1002 Wireless Tax Fairness Act of 2011; State Sales Tax Collection on Internet Sales; FCC Tower Siting Order; Low Power FM Broadcast Radio Stations; FCC Notice of Inquire (NOI) on Broadband Development; and Community Access Preservation (CAP) Act. 7. Staff update on Grant for Technology Opportunities Program (GTOPs) (John Speirs) (wp2)

John Speirs, Program Coordinator with the City of Austin Office of Telecommunications & Regulatory Affairs stated he was bringing the 2012 GTOPs Grant Review Committee's grant recommendations before the Commission tonight for action.

After approval the grant awardees will receive proclamations at the March 22nd City Council meeting at 5:30 pm.

8. Discussion and possible action on the 2012 GTOPs Grant Review Committee grant recommendations. (John Speirs) (wp2)

Motion to accept the 2012 Grant for Technology Opportunities Program (GTOPs) Grant Review Committee's (GTOPs) recommendations as follows: Austin Children's Museum- \$25,305.00, 100% of request; Austin Film Society-\$16,000.00, 80% of request; Austin Free-Net- \$23,985.00, 80% of request; Austin Speech Labs- \$26,100.00, 100% of request; Girlstart- \$15,280.00, 80% of request; Literacy Coalition of Central Texas- \$18,915.00, 70% of request; Skillpoint Alliance-\$27,000.00, 90% of request; and Texas Folklife Resources- \$22,415.00, 70% of request was approved on Commissioner Rosenthal's motion; Commissioner Ramsey's second on a vote of 6-0-0. http://www.ci.austin.tx.us/edims/document.cfm?id=165410

9. Report from Community Technology Assessment Working Group. (Quintanilla) (wp3)

Commissioner Quintanilla reported that she, Commissioners Ramsey and Rosenthal attended this working groups meeting this past month along with City staff John Speirs. About 20 stake holders attended and were very interested. Dr. Straubhaar spoke regarding the data he continues to analyze from the Austin Residential Community Technology Survey.

John Speirs stated the survey data in now part of the City's Open Data Portal

10. Update from Open Government Working Group. (Rosenthal) (wp4)

Commissioner Rosenthal stated this working group consists of Commissioners Rosenthal, Williams and Ramsey, from the City: Stephen Elkins, City CIO; Matt Esquibel, City Web Master; Paul Lewis, TARA Assistant Manager; and Robert Levinski, Councilmember Morrison's office; also Julio Gonzalez, Open Austin; Conner Kenny, formally with the LBJ School of Public Affairs.

The group met March 14, 2012 for an orientation and to discuss the resolution that Council passed regarding open government. This Commission was directed to participate in four areas, open data; open source platform; mobile applications; and social media. At this meeting they mostly discussed open data.

As a group they are going to work on the recommendations for open data and gather some resources and best practices to review.

This group will meet again next month and give an update at this Commissions April regular meeting.

11. Discussion and possible action on revising 2012 workplan to add annotations to City Code. (Williams)
