**MBE/WBE and Small Business Advisory Committee  
Minutes**

**Regular Meeting  
Tuesday, March 3, 2012**

**The MBE/WBE and Small Business Advisory Committee convened in a regular meeting on Tuesday, March 3, 2012 at 301 W. 2<sup>nd</sup> Street Room 1101 in Austin, Texas.**

**1. CALL TO ORDER**

Chair, Ed Lowenberg called the Board Meeting to order at 6:00 p.m.

Board Members in attendance were Ed Lowenberg, Barbra Boeta, Schiller Liao and Regina Adams.

**2. APPROVAL OF MINUTES**

The Committee approved the February 7, 2012 and February 23, 2012 Special Called Meeting minutes on a motion by Ms. Boeta and seconded by Mr. Liao.

**3. CITIZEN COMMUNICATION**

Mr. Paul Saldana, US Hispanic Contractors Association (USHCA) requested the Committee review the Side-By-Side Comparison Minority Chamber and Minority Trade Association Funding handouts for possible recommendations to Council to increase funding for minority trade associations.

Mr. Juan Oyervides, USHCA requested that the Committee review and consider making possible recommendations to increase minority trade association funding.

Ms. Carol Hadnot, Austin Area Black Contractors Association (ABCA) expressed her support of a funding increase to minority trade associations and provided information on association's invaluable benefits and services to its subcontractors.

Ms. Aletta Banks, Asian Contractors Association expressed her support of a funding increase to minority trade associations and outlined its association benefits to subcontractors.

Mr. Behram Atashband expressed general concerns regarding minority contractors and the need for more transparency and fairness in the City's process.

The Committee requested SMBR to add the minority association funding increase to next month's agenda for discussion and possible action.
