Authorize execution of a construction contract with MUNIZ CONCRETE & CONTRACTING INC., (MBE/MH 78.85%) for the 2012 Miscellaneous Bridge Maintenance Project in an amount of \$387,854.00 plus a \$38,785.40 contingency for a total contract amount not to exceed \$426,639.40.

Additional Backup Information	

This project provides necessary bridge maintenance and repair to 10 bridges throughout the City of Austin. The work includes channel scour remediation, curb & gutter repair, driveway, sidewalk and sidewalk ramp repair, metal rail repair, joint sealing, asphalt milling and overlay, and striping on the selected bridges. The work includes all required traffic control measures.

The 10 bridges affected are:

- 1. 15th Street at Red River over Waller Creek
- 2. Burleson Road Bridge Just west of FM 973
- 3. Arroyo Seco Culvert, 5700 Block
- 4. Avenue F at 45th Street Over Waller Creek
- 5. Airport Boulevard 0.2 miles east of I-35
- 6. E. MLK over Boggy Creek 1.2 miles NE of I-35
- 7. McKinney Falls Parkway
- 8. Emerald Forest Block 5300 just north of Radam
- 9. 7200 Loyola
- 10. Robert É. Lee & Barton Springs

Field observations indicate unknown subsurface issues whose magnitude cannot be estimated until the work begins; therefore a 10% contingency in funding has been included to allow for the expeditious processing of any change orders.

The contract allows 100 calendar days for completion of this project. This project is located within the following zip codes: 78617, 78701, 78704, 78722, 78723, 78744, 78745, 78751 and 78756; and the project is managed by the Public Works Department.
