| Is it anticipated that patrons attending the special event will park their vehicles in adjacent neighborhoods and walk to the event? | No. Numerous free shuttle buses are provided from state parking lots and run all day. |

| What is the distance (in feet) from heavily trafficked areas and the proposed temporary designated smoking areas? Heavily trafficked areas include those areas where pedestrian traffic is constantly flowing within the special event venue. | Hike and bike trail along the edge of the hillside are high traffic areas, this would be the East edge of the smoking area. |
| What is the distance (in feet) from areas where people can congregate and the proposed temporary designated smoking areas? Areas where people can congregate include those areas where patrons (more than 3 people) gather within a special event venue, such as food courts, audience-viewing stage area, vendor booths, portable toilets' queue space, water stations, and other areas which attract gatherers for a period of three minutes or longer. | People can congregate anywhere. We will make no attempt to separate groups if more than 3 people stand next to each other anywhere in the park. |
| Are there going to be youth (under the age of 18) attending this event? If so, what are the approximate ages of these youth? | All ages attend. Children usually congregate in the playgrounds and childrens area |
| Can special event patrons leave the event and re-enter as they wish? | There is no entry fee. Patrons may enter and leave as they wish. |
| Is there any more additional information regarding the proposed temporary designated smoking areas that the Department should be aware of? | We will clean the park as we have for the last ~37 years. Pease District Park will be cleaner the day after our event than the day before our event. We involve local scout troops and other youth organizations to assist in park clean up, focusing specifically on cigarette waste. We use this opportunity reinforce to the youth that smoking is bad for them, bad for the environment, and just gross in general. |
