Authorize award and execution of a 24-month requirements supply agreement with A.W. CHESTERTON/CHESTERTON TEXAS, for SXCF grease to lubricate rollers and seals for the Austin Water Utility in an estimated amount not to exceed \$100,486, with two 12-month extension options in an estimated amount not to exceed \$50,243 per extension option, for a total estimated contract amount not to exceed \$200,972.

Amount and Source of Funding

Funding in the amount of \$25,122 is available in the Fiscal Year 2011-2012 Operating Budget of the Austin Water Utility Department. Funding for the remaining 18 months of the original contract period and extension options is contingent upon available funding in future budgets.

The grease serves as both a lubricant for the rollers and the seals; as well as it serves as barrier to keep out as much of the processed water as possible out of the housing of the bearing.
