Authorize award and execution of a 36-month requirement service contract for vehicle cleaning and washing services for the Fleet Services Department with H2O CAR EXPRESS, LLC, in an estimated amount not to exceed \$393,120 with three 12-month extension options in an estimated amount not to exceed \$186,624 for the first extension option, \$223,949 for the second extension option, and \$268,739 for the third extension option, for a total estimated contract amount not to exceed \$1,072,432.

Amount and Source of Funding

Funding in the amount of \$45,000 is available in the Fiscal Year 2011-2012 Operating Budget of Fleet Services. Funding for the 31 remaining months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This contract establishes an annual service agreement for full-serve vehicle cleaning and washing services for city-owned vehicles. The majority of the contract will be used for police patrol sedans and will required special interior cleaning services on vehicles that have been soiled from routine transportation of alleged offenders.

The full-service wash will be performed by vendor supplied attendants on sedans and pickups up to ¾-ton capacity, and will include interior cleaning such as vacuuming, cleaning of windows and mirrors, and exterior cleaning such as wiping and hand drying of the vehicles.

The City of Austin does not have the facilities to provide these services. Award is based on the lowest responsive bidder offered in three geographical zones of the city (North, Central, and South), that provides convenient locations for most city vehicles.
