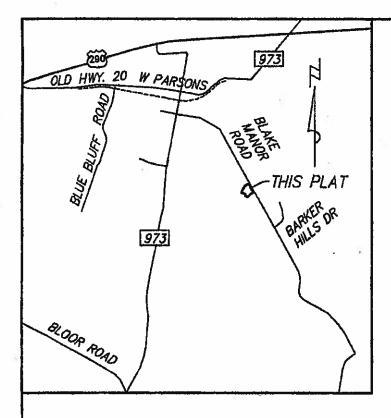
STAFF RECOMMENDATION:
