Subject: Director's Report

Public Recycling

The majority of the City's litter receptacles are located in the Central Business District, approximately 200 receptacles. ARR's Master Plan does call for expanding recycling in public places and with that, there are plans to convert some of these receptacles into recycling receptacles.

In addition, Public Works has agreed to include recycling receptacles in all future street renovations that are part of the Great Streets Program. The Great Streets Program and Public Works are coordinating the renovation of streets in the Downtown area. As these streets are renovated additional receptacles are being placed. This will expand the number of receptacles in the CBD to approximately 400.

Currently the only public receptacle recycling that is available is located between 18th and 31st Street, in the University of Texas area. There are 19 pilot program Big Belly litter/recycling receptacles in this area and the results thus far have been very encouraging. Approximately 50% of the materials being collected in the area are recyclable.

Master Plan – Implementation Update

FY13 Budgetary impact items for implementation of the Master Plan include:

- Marketing Campaigns for Zero Waste Initiatives, Reusable Bags Education and Outreach
- Business Outreach in support of the URO
- Planning, Development and Implementation of five Reuse/Recycle Centers
- RFQ release for Enhanced Gas Capture System
- RFQ release for Landfill Solar Field
- Continued Expansion of CNG Fuel Conversions

Additional staff supported through the FY13 Budget request include:

- Economic and Business Development Liaison
- Marketing Manager to support Zero Waste Program Development
- Waste Diversion Planner to support URO Implementation
- Operator to support Bulk Collection at Resource Recovery Facility

ARR Annual Report

The Department released its 2011 Annual Report on Thursday, May 3, 2012 and includes an overview of the Department's progress toward Zero Waste, achievements in resource recovery, and services provided to Austin residents and businesses. We are extremely proud of this document. It provides a historical look at the Department while proving a glimpse into our future. Highlights include:

- Diverted 38 percent of City-collected materials (83,093 tons) from the landfill
- Collected 127,053 tons of trash, a reduction from 2010
- Composted 30,271 tons of yard trimmings and large brush, an increase from 2010
- Recycled or reused 30 percent of the materials collected at the Household Hazardous Waste Facility, an increase from 2010
- Collected 6,343 tons of litter and debris from City streets
- Serviced 182,681 residential households
- Produced 8,333 gallons of Austin ReBlend paint, available to residents for free at the Household Hazardous Waste Facility
- Produced and broadcast Dare to Go Zero, the City's first reality TV show, in which four Austin families competed to reduce their household trash to zero
- Purchased 17 Compressed Natural Gas trucks, which are projected to use 35 to 50 percent less fuel than traditional trash and recycling trucks
- Installed 19 public trash and recycling containers along Guadalupe Street near The University of Texas at Austin
- Offered 67 free composting classes throughout Austin, teaching three times the number of residents compared to 2010

Printed copies were distributed to the City Manager's Office, City Council and Department Directors. Staff is also distributing printed copies to the Environmental Board, Sustainable Food Policy Board, Resource Management Board, and Water/Wastewater Commission as well as key stakeholders such as our recycling contractors, Block Leaders, and Neighborhood Associations. The full document is also available online and posted on the Department's Facebook site, and we emailed a notification to the entire Zero Waste list serve directing them to the online version. Internally, I have emailed my entire Department and will be distributing copies to all supervisors and managers.

At the April 26th City Council meeting, a proclamation was made to make April 26th Keep Austin's Air Clean Day. Austin Resource Recovery utilizes 4 Hybrid Recycling Collection Vehicles in their Fleet which reduces emission up to 50% in comparison to regular diesel collection vehicles. Assistant Director Tammie Williamson and Operations Division Manager Ron Romero represented ARR at this event.

Council Item Update Request (CIUR) 543: Interlocal agreement with City of Austin and Travis County

The purpose of the ILA is to encourage consistency and collaboration regarding implementation of Zero Waste goals and principles. At the last collaboration meeting, discussions revolved around how we can work together to promote Zero Waste and implement programs to reach Zero Waste. Several options may be available including but not limited to:

- <u>Services</u>. Certain services and contracted services could be shared or extended to each jurisdictions residents or operations, including:
 - Resident access to Household Hazardous Waste facilities
 - City dumpster contract for recycling and trash collection
 - Resident access to Reuse/Recycling Drop-off facilities
 - Contracted food scrap composting services currently utilized by Travis County jail
- Ordinances. After the City of Austin passes an ordinance, it could be shared with Travis County for consideration by the Travis County Community Court for adoption by the County. Certain minimum requirements could be agreed upon in order to maintain consistency across jurisdictions. Ordinances of interest could include:
 - Event Recycling Ordinance
 - Hauler Ordinance
 - Universal Recycling Ordinance, including amendments to the Land Development Code
 - Construction and Demolition Recycling Ordinance

Travis County staff are reviewing the items discussed and will report back to ARR within the next month.




